**3.1 Qualification and Experience of the Post as under:**

**3.2** The above vacancies are provisional and subject to variation. The Executive Director, AIIMS, Bhubaneswar reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India Rules/Circulars and requirements.

**3.3** Reservation will be as per Government of India Policy.

**3.4** The period of experience shall be counted after obtaining the essential qualification.

**4. GENERAL TERMS AND CONDITIONS:**

4.1 The cut-off date to determine the maximum age limit, essential qualifications & experiences will be the date of Skill Test. The applicants appearing in the skill test in response to this advertisement should meet all the eligibility criteria as on date of skill test failing which their application will be rejected.

4.2 Candidates are advised to satisfy themselves before applying that they possess at least the essential qualifications laid down for the post.

4.3 The period of engagement will be for 11(eleven) months or till the post is filled on a regular basis whichever is earlier. Further extension in exigency of the services may be considered by the Competent Authority as admissible under the rules. The engagement will be purely on a contractual basis and it will not bestow any rights implicitly or explicitly upon the candidate to claim any permanent absorption or any liability by AIIMS, Bhubaneswar on termination of the contract. However, the initial tenure of engagement can be less as per the decision of the Competent Authority.

- 4.4 The period of contractual engagement can be terminated by the candidate within 01 month of the notice period or remuneration in lieu of the notice period if he/she resigns from the post prematurely. However, Institute will have the rights to terminate the engagement at any time without citing any reasons.
- 4.5 Concessions for Reservation for SC/ST/OBC/PwBD/EWS will be as per the rule.
- 4.6 The candidates willing to appear for Skill Test may report at **Recruitment Cell, 3<sup>rd</sup> Floor, Academic Block at 10:00 AM on 26<sup>th</sup> May 2023**. The candidate should bring duly filled application proforma attached as Annexure-I along with original & self-attested copies of all the testimonials/certificates in support of the qualification and experience for the applied post. No TA/DA will be paid to the candidates appearing for the Skill Test.
- 4.7 The candidate must possess the educational qualification and experiences as recognised by the Govt. of India. Their candidature will be cancelled at any stage if it is found to violate the terms and conditions as prescribed in the Advertisement.
- 4.8 **Qualifications and Experiences:** Qualifications and experiences as prescribed may be relaxed in exceptional cases at the discretion of the Selection Committee.
