- Bid will be opened on the same day i.e. 22/06/2016 at 11.00 P.M (Sharp). If the
 date of opening of bids happen to be a holiday, then the bids shall be opened on
 the next working day of the same time.
- 4. Bidder(s) can inspect the Items awaiting disposal between 3.00 P.M. to 4.00 P.M. on 20.06.2016 at the above mentioned address in regard to the conditions, quality etc of items and satisfy themselves before submitting their offer by the date and time specified.
- Overwriting or alteration will also disqualify the bids unless these are legible attested by bidder/bidders.
