- 1. No Call letter for Computer Proficiency Test indicating Date and Venue will be sent to above shortlisted candidates by Email/Speed Post.
- 2. The syllabus of Computer Proficiency Test will be as follows
  - a) Module-I (Typing Test on Microsoft Word): 10 Minutes With minimum speed of 35 words per minute in English & 30 words per minute in Hindi
  - **b) Module-II** (Test on Microsoft Excel): 15 Minutes

    The candidates are to be given a printed table which has to be created in MS

Excel and the total 10 marks will be awarded for this module.

- 3. The candidature of all the above-listed candidates shortlisted for the Computer Proficiency Test is purely provisional subject to verification and fulfilment of the eligibility criteria with regards to age, essential qualification, category, age, and experience etc. as per the advertisement and Rules & Regulations of the Institute. In case any of the selected candidates is found not fulfilling any of the eligibility criteria at any stage, then his/her candidature/selection will be cancelled without giving any reason. The decision of the Executive Director in this regard will be final.
- 4. Candidates should note that shortlisting for Computer Proficiency Test does not entitle him/her for an empanelment/appointment in the AIIMS, Bhubaneswar. The candidature of above candidates is purely provisional.
- 5. The Computer Proficiency Test will be only qualifying, those candidates who will secure qualifying marks will be considered for selection based on their merit i.e. mark secured in Computer Based Test. Those who will not qualify the Computer Proficiency Test will not be considered for selection even though they have secured higher marks in Computer Based Test (CBT).
- 6. The final selection will be purely based on merit who fulfil all eligibility criteria as per the advertisement. Action as warranted under Rules/Laws will be taken in respect of those candidates who will bring outside influence in any manner.
- 7. If the candidate does not belong to the category mentioned against his/her name in the Notification or if any of the particulars mentioned are not correct, such candidates are advised to report the discrepancy along with all supporting documents to Assistant Administrative Officer, Recruitment Cell, 3rd Floor, Academic Block, AIIMS, Sijua, Bhubaneswar-19 within 3 days of this notification.
