- 6. The candidates are required to produce No Objection Certificate (NOC) signed by the Competent Authority of their respective organization and not by the candidate himself if happened to be the Issuing Authority at time of interview. No candidate will be allowed to appear for the interview without NOC as per the condition of the Advertisement.
- 7. The candidate will have the option to join through Hybrid Mode (Physical/Online) for interview.
- 8. Those candidates who want to appear for interview physically must bring all original documents in support of their eligibility for the post applied for as well as other documents requested as per the Advertisement No. AIIMS/BBSR/RECT/DEPUTATION/2022/947/7978 dated 27<sup>th</sup> March, 2023.
