The venue, date & reporting time for Computer Proficiency Test (CPT) for the post of Cashier will be intimated separately and also uploaded on the AIIMS, Bhubaneswar's website in due course of time. No separate Call letter for Computer Proficiency Test(CPT) indicating Date and Venue will be sent to above shortlisted candidates.
2. The syllabus of Computer Proficiency Test will be as follows-
 - 1. Module-I (Test on Microsoft Word): 15 Minutes**
With minimum 2000 key depression, who make 2000 key depression or above will be awarded 20 marks and other will be awarded proportionate marks.
 - 2. Module-II (Test on Microsoft Excel) :15 Minutes**
The candidates are to be given a printed table which has to be created in MS Excel and a total 10 marks will be awarded for this module.
3. A candidate who score 18 marks out of total 30 marks of the combined two modules will be declared successful in the Computer Proficiency Test (CPT).
4. The candidature of all the above-listed candidates shortlisted for the Computer Proficiency Test (CPT) is purely provisional subject to verification and fulfilment of the eligibility criteria with regards to age, essential qualification, category, age and experience etc. as per the advertisement and Rules & Regulations of the Institute. In case any of the selected candidates is found not fulfilling any of the eligibility criteria at any stage, then his/her candidature/selection will be cancelled without giving any reason. The decision of the Executive Director in this regard will be final.
5. Candidates should note that shortlisting for Computer Proficiency Test (CPT) does not entitle him/her for an empanelment/appointment in the AIIMS, Bhubaneswar. The candidature of above candidates is purely provisional.
6. The Computer Proficiency Test (CPT) serves as a qualifying stage; candidates securing qualifying marks will be eligible for final selection based on their merit, determined by their performance in the Computer Based Test (CBT). Candidates who do not meet the qualifying criteria in the Computer Proficiency Test (CPT) will not be considered for selection, regardless of achieving higher scores in the Computer Based Test (CBT).
7. The final selection will be solely based on merit, considering candidates fulfilling all eligibility criteria as per the advertisement. Any attempt by candidates to exert outside influence in any form will result in appropriate actions taken in accordance with the established Rules/Laws.
8. If a candidate does not belong to the category mentioned against his/her name in the Notification or if any of the particulars mentioned are not correct, such candidates are advised to report the discrepancy along with all supporting documents to Assistant Administrative Officer, Recruitment Cell, 3rd Floor, Academic Block, AIIMS, Sijua, Bhubaneswar-19 within 3 days from the date of issue of this notification.
9. No TA/DA shall be paid for the aforementioned Computer Proficiency Test (CPT).
