The seniority will be determined as per the common merit list of all selected candidates, irrespective of the date of the joining of the candidates. The candidates are being called for document verification, and the offer of appointments will be issued as per the terms and conditions of the advertisement.
- **5.** Candidates are requested to bring the following original documents along with one set of self-attested photocopies:
