Shortlisted candidates have to report for document verification and subsequent walk-in interview. The shortlisted candidates should come for the interview with the duly filled application form (As per the prescribed Performa) and photocopies of educational qualifications and experience certificates along with the original certificates (for verification) and a passport-size photo.

## General Instructions:

1. Candidate should type "Application for the post of Research Staff (Project Technical Support–III)" in the subject line while sending their application through e-mail.
2. These are tenure vacancies under the funded project and are not employment on the AIIMS Bhubaneswar payroll. Employment will be automatically terminated upon completion of the project and there is no liability for permanent employment on AIIMS, Bhubaneswar or Principal Investigator. Also, the candidates have no right to claim permanent employment based on this job. No benefit of Provident fund, Hostel accommodation, Leave Travel Concession, Medical Claim etc. will be considered, since the post is purely on contract basis.
3. Candidates who fail to bring the original certificates at the time of joining and if any discrepancy is found in the documents such candidates will not be allowed to join the selected contract post and the position will be offered to the waiting list candidates.
4. Age relaxation for SC/ST/OBC/PWD Candidates will be as per the government rules.
5. Cut-off date for age limit will be the date of Walk-In-Interview i.e. date of interview (27/10/2023).
6. Qualification/degree should be in relevant discipline from a Government approved reputed Institution/University.
7. The experience requirement specified should be experience acquired after obtaining the minimum educational qualifications required for the post.
8. Canvassing in any form will be a disqualification.
9. No TA/DA will be paid either for attending the interview or joining the post.
10. Persons already in regular time-scale service under any Government Department / Organization are not eligible.
11. The Director and appointing authority has the right to accept/reject any application without assigning any reason and no correspondence in this matter will be entertained.
12. If the candidate is not eligible, his / her candidature will be cancelled at any stage of the recruitment process. If the candidate qualifies in the selection process and subsequently, it is found that he/she does not fulfil the eligibility criteria, his / her candidature will be cancelled and if appointed, services so obtained will be terminated without any notice or compensation.
13. The engagement can be terminated at any time by giving one-month notice on either side. Contract can be terminated forthwith or before expiry of the notice period by making payment of a sum equivalent to one-month contractual amount. 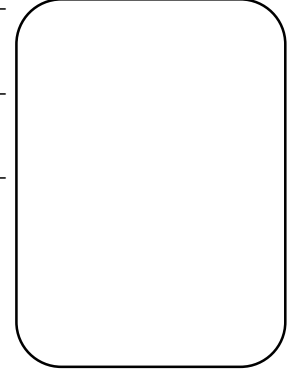
