TERMS & CONDITIONS

1. Bid should be signed by bidder(s) himself/themselves or a person duly authorized in his/their behalf. A copy of such authority should be enclosed alongwith the offer.
2. Bids may be furnished in the following format (**Annexure-A**) and Bid forms are not transferable.
3. Bid will be opened on i.e. 19.03.2019 at 12.00 P.M (Sharp). If the date of opening of bids happen to be a holiday, then the bids shall be opened on the next working day of the same time.
4. Bidder(s) can inspect the Items awaiting disposal between 3.00 P.M. to 4.00 P.M. on 18.03.2019 at the above mentioned address in regard to the conditions, quality etc of items and satisfy themselves before submitting their offer by the date and time specified.
5. Overwriting or alteration will also disqualify the bids unless these are legible attested by bidder/bidders.
6. The Sales-tax and other levy if any; will have to be paid extra by the successful bidder.
