The candidates are required to produce No Objection Certificate (NOC) signed by the Competent Authority of their respective organization and not by the candidate himself if happened to be the Issuing Authority at time of interview. No candidate will be allowed to appear for the interview without NOC as per the condition of the Advertisement.
