Applications are invited for the post of "**Project Technical Support- III**" for the ICMR-funded research project titled "**Maintenance Electroconvulsive Therapy (M-ECT) Versus Aripiprazole On Psychopathology And Cerebral Perfusion In Clozapine-Resistant Schizophrenia: A Randomized Double-Blind Controlled Trail**" in the Department of Psychiatry under PI Dr Biswa Ranjan Mishra, Professor for a maximum tenure period of 02 and ½ years at the AIIMS, Bhubaneswar. Interested candidates may appear for a walk-in interview on 03.07.2024, Reporting Time from 09.30 AM to 11.30 AM at the Seminar room, Psychiatry OPD, AIIMS, Bhubaneswar. The candidates should come for the interview with the duly filled application form (As per the prescribed Performa), Photocopies of educational qualifications and experience certificates along with a passport-size photo. The documents will be verified by a scrutiny committee on the same day, and the eligible candidates will be called to attend the offline interview.

TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Even after qualifying in the selection process the candidate may be rendered disqualified at the time of document verification if he/she does not fulfill essential eligibility criteria.
2. **Tenure:** The assignments are purely on a contract basis for a period of **2½ years**. These Appointments will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS, Bhubaneswar/ICMR or continued contractual appointment.
3. **Expiry of Contract:** The contract will automatically expire on completion 30 months or earlier in case of withdrawal of support by funding agency. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
4. **Leave:** The leave entitlement of the appointee shall be governed in terms of the ICMR leave policy as amended from time to time.
5. **Accommodation:** No hostel or any other accommodation will be provided by the institute.
6. **Canvassing of any kind will lead to disqualification.**
7. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
8. The appointment is full time and private practice of any type is prohibited.
9. The research project for which contractual appointment is being done requires office work.
10. He/ She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
