

INSTRUCTION - 1 FOR CANDIDATES – AIIMS Bhubaneswar MBBS 2020

Candidates are advised to verify the certificates detailed below against their respective category before reporting to AIIMS Bhubaneswar for admission to MBBS course for availing constitutional or horizontal reservation.

NOTE: Failure to produce any of the certificates mentioned below in original and their photocopies during verification will lead to forfeiture of the allotted seat. No additional time or opportunity will be provided for producing the certificates.

Other Backward Class (OBC) Category:

1. Candidates are instructed to refer to the central list of Other Backward Class (OBC) categories at http://www.ncbc.nic.in/User_Panel/CentralListView.aspx
2. Community name should be there in the central list.
3. The certificate format should be as mentioned in the NTA NEET 2020 Information Bulletin, <https://ntaneet.nic.in/Ntaneet/ShowPdf.aspx?Type=50C9E8D5FC98727B4BBC93CF5D64A68DB647F04F&ID=1B6453892473A467D07372D45EB05ABC2031647A>, page 86, Appendix XI: Proforma for Other Backward Class (OBC-NCL) certificate.
4. The certificate should be valid i.e. the date of issue of the Certificate to be produced during seat allocation should **NOT** be older than one year. The validity of certificate shall be 06th November 2019 to 05th November 2020.

Please note:

The certificates will not be accepted,

- If it is in any other format other than as mentioned in Appendix XI
- If 'non-creamy layer' or 'does not belong to creamy layer/section' is not mentioned
- If community /sub caste is not listed in the central list
- If the certificate was issued prior to 6th November 2019 or after 05th November 2020.

Scheduled Caste/ Scheduled Tribe (SC/ST) Category:

1. Scheduled Caste/Scheduled Tribe Community Certificate, should be obtained from the competent authority.
2. The certificate should be as per the format mentioned in the NTA NEET Information Bulletin <https://ntaneet.nic.in/Ntaneet/ShowPdf.aspx?Type=50C9E8D5FC98727B4BBC93CF5D64A68DB647F04F&ID=1B6453892473A467D07372D45EB05ABC2031647A>, page 85, Appendix X: Proforma for Scheduled Caste and Scheduled Tribe Certificate.

Economically Weaker Sections (EWS)s Category:

1. Candidates should produce the required Income & Asset Certificate as (as mentioned in the NTA NEET Information Bulletin)
2. The certificate should be issued by competent authority not below the rank of Tehsildar
3. Income Certificate will not be considered equivalent to EWSs certificate under any circumstances.
4. The certificate should be valid i.e. the date of issue of the Certificate to be produced during seat allocation should **NOT** be older than one year. The validity of certificate shall be 06th November 2019 to 05th November 2020.

Please note:

Reservation for EWS shall be according to the rules of the Government of India. Applicants will be required to produce the necessary certificate in the format provided at the end of the prospectus in support of his/her claim. Persons with Benchmark Disability (PwD):

2. No other medical certificate will be accepted under any circumstances.
