TERMS AND CONDITIONS :

- The candidates have to possess the minimum qualification and experiences for the post for which she/he is applying.
- Age relaxation for SC/ST/OBC/PwBD candidate will be applicable as per the rules.

- The period of engagement will be for a period of 1(One) year or the post is filled on regular basis whichever is earlier.
