I. The above temporary vacancies are provisional and subject to variation. The Director, AIIMS, Bhubaneswar reserves the right to increase/decrease the number of positions including reserved positions as per the Govt. of India rules/circulars and regulations.

II. Reservation for OBC, SC, ST & Physically Handicapped candidates will be made as per the Govt. of India guidelines and Rules.

(A) TERMS AND CONDITIONS:

- (I) The engagement shall be on contractual basis for a period of Eleven Months or till the regular appointment being made which ever is earlier. In no case the engagement will be extended beyond 11 (Eleven) months of contractual period.
- (II) All the above temporary contractual positions shall carry a consolidated pay of Rs. 75,000/- (Rupees Seventy Five thousand only) per month. No other allowances will be paid.
- (III) **Upper Age Limit:** 50 (Fifty) years for all contractual positions.
- (IV) The effective date up-to which the requisite experience must be completed will be the date of Walk-in-Interview i.e 11th April 2014.
- (V) The applicants are required to submit a **bio-data** alongwith attested copies of certificates/testimonials, other relevant documents viz. Caste Certificate issued by the competent authority of Govt. of India, Medical Council Registration Certificate etc. with recent passport size photograph and documentary evidence on the date of Walk-in-Interview.

- (VI) The engagement on contractual basis will not confer on any claim as of right or otherwise for consideration for regular engagement in AIIMS, Bhubaneswar.
- (VII) The applicants already in Government service/Autonomous Bodies/PSU shall have to produce **NO OBJECTION CERTIFICATE** from their present employer at the time of interview failing which his/her candidature will be rejected.
- (VIII) The post(s) is/are whole time basis and private practice of any kind is prohibited.
- (IX) The persons belonging to SC/ST/OBC community, Physically Challenged must submit the certificate in the requisite proforma duly issued by the concerned authority of Govt. of India.
- (X) Canvassing of any kind will be a disqualification.
