The All India Institute of Medical Sciences (AIIMS) Bhubaneswar intends to dispose off “**Miscellaneous Scrapes**” as **One Lot** at 12:00 P.M on 27.07.2021 by inviting price bids as per the following terms and conditions

Interested bidders may report at the office of Stores & Purchase Officer, AIIMS, Bhubaneswar to inspect the materials and take part in the auction process at the appointed place, date, and time. The successful bidder has to deposit the auction sales price in full and lift the material after the bid process is over.

TERMS & CONDITIONS

1. Bid should be signed by bidder(s) himself/themselves or a person duly authorized in his/their behalf. A copy of such authority should be enclosed along with the offer.
2. Bids may be furnished in the following format (**Annexure-A**) and Bid forms are not transferable.
3. Bid will be opened on i.e. 27.07.2021 at 12.00 P.M (Sharp). If the date of opening of bids happen to be a holiday, then the bids shall be opened on the next working day of the same time.
4. Bidder(s) can inspect the lot awaiting disposal between 2.00 P.M. to 4.00 P.M. on 26.07.2021 at the above mentioned address in regard to the conditions, quality etc of items and satisfy themselves before submitting their offer by the date and time specified.
5. Overwriting or alteration will also disqualify the bids unless these are legible attested by bidder/bidders.
6. The Sales-tax /GST and other levy if any, will have to be paid extra by the successful bidder. The bidder will have to pay GST @ 18% extra on the quoted price.

7. EMD Rs. 4,000/- in the form of FDR /BG from any nationalized bank valid for 06 month drawn in favour of AIIMS Bhubaneswar should be submitted along with the bid.
8. It will be presumed that the bidders before submitting the offer have read carefully all the terms and conditions and accepted the same in full, deviations from the terms and conditions as given in this are not permitted. Any such conditional bid and/or telegraphic bid is liable to be rejected and no alterations shall be allowed after the bid is submitted. No counter terms and conditions shall be accepted.
9. Right to include any other conditions, notify, or alter any of the bid conditions already stipulated is reserved by the Director, AIIMS, Bhubaneswar.
10. All goods constituting the lot will be sold **“AS IS WHERE IS BASIS”**. Bidder will be deemed to have the clear understanding that they have satisfied themselves fully in regard to the conditions, quality and quantity of items proposed to be auctioned.
11. In the event of non-removal of the materials the EMD of the Successful bidder will be forfeited and he will not be allowed to participate in future for such auction sale.
12. The bidder whose bid will be accepted shall have to deposit full offered amount within two days of issue of award of auction.
