Interested parties may report at the office of Store & Purchase Officer, AIIMS, Bhubaneswar to inspect the materials and take part in the auction process at the appointed place, date, and time. The successful bidder has to deposit the auction sales price in full and lift the material after the bid process is over.

TERMS & CONDITIONS

1. Bid should be signed by bidder(s) himself/themselves or a person duly authorized in his/their behalf. A copy of such authority should be enclosed alongwith the offer.
2. Bids may be furnished in the following format (**Annexure-A**) and Bid forms are not transferable.
3. Bid will be opened on i.e. 07.06.2019 at 12.00 P.M (Sharp). If the date of opening of bids happen to be a holiday, then the bids shall be opened on the next working day of the same time.
4. Bidder(s) can inspect the Items awaiting disposal between 3.00 P.M. to 4.00 P.M. on 06.06.2019 at the above mentioned address in regard to the conditions, quality etc of items and satisfy themselves before submitting their offer by the date and time specified.
5. Overwriting or alteration will also disqualify the bids unless these are legible attested by bidder/bidders.
6. The Sales-tax and other levy if any; will have to be paid extra by the successful bidder.

7. It will be presumed that the bidders before submitting the offer have read carefully all the terms and conditions and accepted the same in full, Deviations from the terms and conditions as given in this are not permitted. Any conditional bid and/or telegraphic bid is liable to be rejected and no alterations shall be allowed after the bid is submitted. No counter terms and conditions shall be accepted.

10. In the event of non-removal of the materials the EMD of the Successful bidder will be forfeited and he will not be allowed to participate in future for such sale.
11. The bidder whose bid will be accepted shall have to deposit 25% of the offered amount immediately on the spot and balance of the offered amount will be deposited within 48 hours.
12. If the bidder fails to remove the materials with/in the time limit, the ground rent @1% of the bidding amount will be charged for each day till removal of the article.
