All India Institute of Medical Sciences, Bhubaneswar an Autonomous Institute of National Importance is one of the new AIIMS and apex healthcare Institute, established by the Ministry of Health & Family Welfare, Government of India under the **Pradhan Mantri Swasthya Suraksha Yojana (PMSSY)** with the aim of correcting regional imbalance in quality tertiary level healthcare in the country, and attaining self-sufficiency in graduate, postgraduate and higher medical education and training.

AIIMS, Bhubaneswar is going to conduct Walk-in-interview (**Hybrid Mode**) on **12th March 2024** at **14:00 Hrs (Onwards)** for the following Faculty posts on Contractual Basis.

A medical Qualification included in the I or II schedule or part II of the third schedule to the Indian Medical Council Act of 1956 (Persons possessing qualifications included in part II of third schedule should also fulfil the conditions specified in section 13(3) of the Act.)</p> <p>2. A postgraduate qualification e.g. MD/MS or a recognized qualification equivalent thereto in the respective discipline/subject.</p> <p><u>Experience:</u></p> <p>Three years teaching and/or research experience in recognized Institution in the subject of specialty after obtaining the qualifying degree of M.D. /M.S. or qualification recognized equivalent thereto.</p>

Note: -

1. Qualifications and experiences as prescribed may be relaxed in exceptional cases at

the discretion of the Selection Committee. **The experience will be counted as on the date of walk-in interview.**

2. Relaxation of One-Year Teaching/Research experience for SC/ST Candidates will be given as per Rules/ Guidelines issued by DoP&T.
3. The engagement will be for a period of 01(one) year or till the post is filled on regular basis, whichever is earlier. Further extension in exigency of the services may be considered by the Competent Authority as admissible under the rules. The engagement will be purely on contractual basis and it will not bestow any rights implicitly or explicitly upon the candidate to claim any permanent absorption or any liability by the AIIMS, Bhubaneswar on termination of the contract. However, the initial tenure of engagement can be less than one year as per the decision of the Competent Authority.
4. The period of contractual engagement can be terminated by the candidate within 1 month of notice period or remuneration in lieu of the notice period if he/she resigns from the post prematurely. However, Institute will have rights to terminate the engagement at any time without citing any reasons.

Important Notes:

I) APPLICATION PROCESS:

The candidates, willing to appear for interview may report at **Video Conferencing Room, Ground Floor, Academic Block, AIIMS, Bhubaneswar** at **10:00 AM on 12.03.2024**. The candidate should bring duly filled application proforma attached as Annexure-I along with original & self-attested copies of all the testimonials/certificates in support of the qualification and experience for the applied post. No TA/DA will be paid to the candidates appearing for the interview.

II) MAXIMUM AGE LIMIT & AGE RELAXATION

- Age limit for Assistant Professor is not more than 50 years as on the date of interview. Age relaxation for SC/ST/OBC/PwBD candidate will be applicable as per the rules.
- No age relaxation would be available to SC/ST/OBC/EWS candidates applying for unreserved vacancies.

III) RESERVATION

- Reservation for SC/ST/OBC/EWS/PwBD will be as per Government of India Policy Candidates applying against any of the reserved category posts, viz. SC/ST/OBC/PwBD/EWS will be considered on production of valid Caste/PwBD/EWS Certificate issued by the Appropriate/Competent Authority on the prescribed format. Community should be clearly and legibly mentioned in the Certificate.
- Applicants applying for the posts reserved for OBC must obtain certificate of OBC (non-creamy layer) in the prescribed format issued by Competent Authority. The certificate should be of the current financial year and in accordance with instructions issued by the Government of India in this respect from time to time. Applicants should ascertain that they belong to the reserved categories (caste) enlisted in the Central List for the Other Backward Classes. OBC candidate(s) should not belong to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s).
- Reservation for Economically Weaker Sections (EWSs) shall be applicable as per Govt.

of India, Office Memorandum No. 36039/1/2019-Estt (Res) DoPT dated 19th January, 2019 and 31st January, 2019. EWS candidate must ensure that they have a valid EWS certificate as on the cut-off date. EWS Candidates are required to attach certificate issued by the competent authority in the format prescribed as per guidelines of Govt. of India.

- 4% of the total vacancies are horizontally reserved for PwBD candidates as per the Ministry of Social Justice and Empowerment's Notification No. 16-15/2010-DD.III dated 29th July, 2013 as amended from time to time as applicable. Only such persons would be eligible for reservation under PwBD quota in service/posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in prescribed format. However, the candidature of PwBD applicant is subject to evaluation by a Medical Board duly constituted by the Executive Director, AIIMS, Bhubaneswar. This Medical Board will evaluate suitability of candidates for the post he/she is being considered for. All the instructions of Govt. of India as amended and as applicable in this matter will be followed if the same is not consistent in this connection.

IV) NO OBJECTION CERTIFICATE:

- The applicants who are already in Government service (including AIIMS Employees) shall have to produce No Objection Certificate from their present employer at the time of Interview. However, they have to take prior permission from their employer while applying for the post. No candidate will be allowed to appear for the interview without NOC from his employer.

V) METHOD OF SELECTION:

- The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection. The methodology of Selection will be decided by the Selection Committee as deemed fit besides any other matter relating to the selection process.

VI) OTHER TERMS & CONDITIONS

- AIIMS, Bhubaneswar decision is final: The decision of the AIIMS, Bhubaneswar in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, methodologies for the selection, and allotment of posts to selected candidates will be final and binding on the candidates and no enquiry / correspondence will be entertained in this regard.
- Any corrigendum or revision of the advertisement or any other information regarding this recruitment will be posted on the Official website of AIIMS, Bhubaneswar only in due course. Candidates are advised to visit our website regularly for updated information in this regard.

INFORMATION TO THE CANDIDATES

1. The All India Institute of Medical Sciences is an autonomous body established under Act of Parliament.
2. Service under the Institute is governed by that Act and the Rules & Regulations framed thereunder.
3. The Institute strives to have a workforce which reflects gender parity and women candidates are encouraged to apply.

- . All the posts carry usual allowances as admissible to Central Government Employees of similar status at Bhubaneswar, Odisha.
5. The post(s) is/are whole time and private practice of any kind is prohibited.
6. The candidates are likely to be posted at rural health and urban health centers or other centers attached with the Institute for the period to be decided by the Institute as applicable.
7. Canvassing of any kind will be a disqualification.
8. The candidate should not have been convicted by any Court of Law.
9. In case any information given or declaration by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and any action as deemed fit shall be taken by the Appointing Authority.
