5. **Those candidates who are in Govt. Service (including AIIMS Employees) are required to produce No Objection Certificate (NOC) within the stipulated timeline.** No candidates will be allowed to appear for the Interview without NOC as per the conditions of the advertisement.
6. Applicants applying for the posts reserved for OBC must obtain certificate of OBC (Non- Creamy Layer) in the prescribed form issued by Competent Authority. The certificate should be of the **Financial Year 2024-25**, in accordance with instructions issued by the Government of India in this respect from time to time. Applicants should ascertain that they belong to the reserved Categories (Caste) enlisted in the Central List for the Other Backward Classes.
