The GB appreciated the CSR initiative of MCL towards setting up the project "ZAP-X system towards treatment of Head & Neck Tumor/Cancer at AIIMS, Bhubaneswar and stated that it will be highly beneficial for the management of Head & Neck cancer patients of Odisha and its neighbouring States. The GB unanimously approved the project and directed the Institute to take a swift action to start the project by signing of MoU with MCL.

Decision regarding Reimbursement of medical bill amounting ₹32,67,723/- of Dr. Nerbadyswari Deep Bag, Professor & HoD, Dept. of Radiodiagnosis covered under AllMS Bhubaneswar Employee Health Scheme (ABEHS)

Taking into consideration of urgency and critical nature of medical condition of her husband, the GB has considered her claim for reimbursement of medical bill amounting ₹32,67,723/- of Dr. Nerbadyswari Deep Bag, Professor & HoD, Dept. of Radiodiagnosis covered under AIIMS Bhubaneswar Employee Health Scheme (ABEHS) and approved the said claim of Dr. Nerbadyswari Deep Bag by condoning the delay of submission of medical claims, as a one-time measure. It is also instructed to the institute to adhere to the laid down policy & guidelines on the subject.

Proposal for a decision to place Dr. Chinmaya Dash, Associate Professor, Department of Trauma & Emergency, AllMS, Bhubaneswar, under "Suspension" as per the provisions made under Rule-10 of CCS (CCA) Rules, 1965, with immediate effect due to violation of proper channel of communication in writing various complaints/representations directly to the higher functionaries, admitting elective cases through emergency and performing interventional procedures by inviting outside specialists to AllMS, Bhubaneswar.

The GB deliberated the matter and found that Dr. Chinmaya Dash, Associate Professor, Department of Trauma & Emergency, AllMS, Bhubaneswar is habitual in writing numerous baseless complaints, unsubstantiated claims and spreading misinformation by representations on various issues against the AllMS Authorities directly to the higher functionaries in violation of CCS(Conduct) Rules, 1964. In spite of Administrative warning issued to him, he does not refrain himself from such writing without following the proper channel of communication and continued to do so as on date.

Dr. Dash also issued with charge sheet in the matter regarding his complaint against Dr. Mahalingam Venkateshan, wherein Dr. Dash was found involved in operating patients without admitting them.

In addition, Dr. Dash was involved in admitting elective cases through emergency under him and getting interventional procedures performed by specialists from outside AIIMS, Bhubaneswar on 19.10.2023, and on multiple occasions, which is a serious unethical clinical practice and procedures involving medico-legal issues and probable financial irregularities.

Therefore, the GB took cognizance of the above matter and noted the act of gross misconduct of Dr. Chinmaya Dash. Taking into consideration of the Interim Report and Final Report of the Inquiry Committee, the GB decided not to place Dr. Dash under suspension and directed the institute to initiate disciplinary proceedings under Rule – 14 of CCS(CCA) Rule, 1965 against Dr. Chinmaya Dash, Associate Professor, Department of Trauma & Emergency, AlIMS, Bhubaneswar in a time bound manner.

The Member Secretary thanked all the members for their active participation and valuable inputs to the decision making of the Governing Body. Further, the Member Secretary appreciated the presence of all the members of the GB by sparing their valuable times and sought for constant guidance for further development of this Institute. The meeting ended with vote of thanks to the Chairperson and all other members who attended the meeting.
