## **INSTRUCTIONS TO BIDDERS (ITB)**

**1.1** The Bidders must go through the complete Tender Document for details before submission of their Bids. The bid submitted by Bidder and all subsequent correspondence and documents relating to the bid exchanged between Bidder and the Procuring Entity shall be written in English or the Official Language. However, the language of any printed literature furnished by Bidder in connection with its bid may be written in any other language provided a translation accompanies the same in the bid language. For purposes of interpretation of the bid, translation in the language of the bid shall prevail. Instructions to Bidders shall form part of this bid document and consequent contract out of this bid.

**1.2** The Bidder shall bear all costs associated with the preparation and submission of its bid and AIIMS, Bhubaneswar will in no case be held responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

**1.3 Bid Validity:** The validity of the Bid/ Tender Document shall be 180 DAYS from the date of opening of the bid.

**1.4 Bidder's Eligibility:** Tender should be quoted only by the original manufacturer (OEM) or by their Authorized Distributor or Selling Agent. Bidder other than OEM shall submit a current authority letter from the original manufacturer concerned in the format given at "**Annexure-III**".

**1.4.1** The bidder must be a natural person, private entity or public entity (State-owned enterprise or institution).

**1.4.2** The bidder must not be a Joint Venture/ Consortium (an association of several persons, firms, or companies- hereinafter referred to as JV/C).

**1.4.3** The bidder must not be insolvent, in receivership, bankrupt or being wound up, not have its affairs administered by a court or a judicial officer, not have its business activities suspended and must not be the subject of legal proceedings for any of these reasons.

**1.4.4** The bidder must not be convicted (within three years preceding the last date of bid submission) or stand declared ineligible/ suspended/ blacklisted/ banned/ debarred by appropriate agencies of Government of India from participation in Tender Processes of all of its entities.

**1.4.5** The bidder must not be of the near relations of executive of Procuring Entity involved in this Tender Process.

**1.4.6** Any bidder having a conflict of interest, which substantially affects fair competition, shall not be eligible to bid in this tender. Bids found to have a conflict of interest shall be rejected as non-responsive.

**1.4.7** Any bidder (as defined in paragraph 6 of the Order No. F. No. 6/18/2019-PPD dated 23.07.2020 issued by Ministry of Finance Department of Expenditure Public Procurement Division) from a country which shares a land border with India will be eligible to bid in this tender if the bidder is registered with the Competent Authority as prescribed in the aforesaid order. Proof of such registration should be enclosed with the bid documents.

**1.4.8** In case where the manufacturer has submitted the bid, the bids of its authorized dealer will not be considered and EMD will be returned.

**1.4.9** Any bidder (as defined in paragraph 6 of the Order No. F.No. 6/18/2019-PPD dated 23.07.2020 issued by Ministry of Finance Department of Expenditure Public Procurement Division) from a country

which shares a land border with India will be eligible to bid in this tender if the bidder is registered with the Competent Authority as prescribed in the aforesaid order. Proof of such registration should be enclosed with the bid documents. In case where the manufacturer has submitted the bid, the bids of its authorized dealer will not be considered and EMD will be returned.

**1.4.10 OEM Turn Over Criteria:** The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be Rs. 34,00,000.00 (Rupees Thirty Four Lakh only). Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

**1.4.11 Bidder Turn Over Criteria:** The minimum average annual financial turnover of the Bidder of the offered product during the last three years, ending on 31st March of the previous financial year, should be Rs8,30,000/- (Rupees Eight Lakh Thirty Thousand only). Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the Bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

**1.4.12 Experience Criteria:** The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt. Organization / PSU / Public Listed Company for Three years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

1.4.13 If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. This Policy is meant for procurement of only goods produced and services rendered by MSEs. Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the policy.

1.4.14 If the bidder is a Start-up, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

1.5 Bidders are required to quote strictly as per specification of the equipment/ instruments/ apparatus. Deviation, if any to specification, must be brought out clearly giving deviation statement in Annexure-IV.

**Exemption from EMD:** Following categories of Sellers shall however, be exempted from furnishing Bid Security:

- 1.6.1 Firms registered with **NSIC** (for sale of Medical Equipment/Instrument/ Apparatus) are exempted from submission of EMD (subject to the financial limits indicated in the NSIC certificate). Govt. of India/State Government departments/Undertakings are also exempted from EMD. However, the respective departments/ firms have to submit the relevant certificate (NSIC etc.) and financial limit to avail this exemption.
- 1.6.2 **Micro and Small Enterprises (MSEs)** who are holding valid Udyam Registration and are manufacturer of the offered Product or Service (Primary Product / Service - in case of bunch bid with total value wise evaluation) and give specific confirmation to this effect at the time of bid submission and claim EMD exemption and whose credentials are validated online through Udyam Registration website of Ministry of MSME and also through supporting document uploaded during bidding process and validated by the Buyer. Under MSE category, only manufacturers for goods and Service Providers for Services are eligible for exemption from EMD. Traders are excluded from the purview of this Policy.
- 1.6.3 **Start-ups** as recognized by Department for Promotion of Industry and Internal Trade (DPIIT), holding valid Start-up Recognition Certificate which is to be uploaded while bidding and claiming EMD exemption and to be validated by the Buyer. Bidder to ensure that turnover for any of the financial years has not exceeded beyond limits prescribed in the certificate / Start Up scheme of DPIIT.

## 1.7 Clarification of bidding documents:

The Tender Inviting Authority shall not be responsible for individually informing the prospective bidders for any notices published related to this bid. Bidders are requested to browse e-Tender portal or website of the Tender Inviting Authority for information/general notices/amendments to bid document etc. on a day to day basis till the bid is concluded before submission of bid.

A prospective bidder requiring any clarification of the bidding documents shall contact the purchaser in writing at the purchaser's e-mail address i.e. [spo@aiimsbhubaneswar.edu.in](mailto:spo@aiimsbhubaneswar.edu.in) & [sp\\_helpdesk@aiimsbhubaneswar.edu.in](mailto:sp_helpdesk@aiimsbhubaneswar.edu.in) The purchaser will respond in writing (through e-mail) to any request for clarification, provided that such request is received not later than 02 (Two) days prior to the deadline for submission of bids.

### **1.8 Amendments in Bidding Documents:**

- (i) At any time prior to the dead line for submission of Bid, the Tender Inviting Authority may, for any reason, modify the bid document by amendment and publish it in e-tender portal and AIIMS, Bhubaneswar website.
- (ii) At any time till **02 (Two) days** before the deadline for submission of bids, the AIIMS, Bhubaneswar may, for any reason, whether at own initiative or in response to a clarification requested by a prospective bidder, modify through amendment. All amendments will be uploaded on the website regularly. AIIMS, Bhubaneswar shall not be responsible to notify the amendments to individual bidders. All amendments by the AIIMS, Bhubaneswar till 02 (Two) days before the deadline for submission of bids, shall be binding on the participatory bidders.

### **1.9 Terms of Two Bid System:** The Tender shall be submitted in 02 (Two) Parts On-line:

**1.9.1 Technical Bid:** All required documents to be submitted online.

**1.9.2 Financial Bid:** Financial Bid is to be submitted on-line. The Financial Bid of bidders, who qualify at Technical Bid Evaluation, will be opened thereafter. While submitting Financial Bid following points need to be taken care of by the bidder.

**1.9.2.1** The Rates are to be quoted in the given format as per **Annexure-VI & VII**.

**1.9.2.2** All quoted rates should be inclusive of packaging & forwarding charges, insurance charges & freight (transportation) charges, other incidental charges and GST (percentage of GST must be mentioned clearly).

**1.9.2.3** Equipment shall be supplied & installed **FREE OF COST** at AIIMS, Bhubaneswar with 01 (One) Year Comprehensive On-Site Warranty inclusive of all spares & labour charges and no extra cost to the Institute with this regard. If the Contract is extended, then additional On-site Warranty as deemed fit need to be arranged by the supplier.

**1.9.2.4** The rates should be quoted in Indian Rupees in figures as well as in words.

**1.9.2.5** If a firm quotes NIL charges/ consideration, the bid shall be treated as unresponsive and will not be considered.

**1.9.2.6** After due evaluation of the bids, Institute will award the contract to the responsive Bidder who has quoted the Lowest Cumulative Unit Price of all consumables including GST as per financial bid (Part-I), subject to MII preference clause. Taxes has to be mentioned clearly in percentage.

**1.9.2.7** Consumable Prices quoted by Bidder shall remain firm and fixed during the currency of the contract and not subject to variation on any account.

**1.9.2.8** For evaluation of price bid to decide L-1, the rates of consumables as per financial bid (Part-I) will be the deciding factor. All the Consumables & Test reagents will be taken from one vendor only. However, consumables other than the Items in Financial Part-I (if any) required for the process in Financial Bid (Part-II) are for reference and evaluation purpose only.

**1.9.2.9** The Annual Test Load is approximate. The mentioned number of tests in the financial bid is only for comparative purpose for price bid evaluation. The department reserves the right to carry out and pay for decreased/ increased number of tests.

### **1.9.3. Manual Submission of Following Documents in ORIGINAL:**

The following documents are to be sent to Sr. Procurement-Cum-Store Officer, AIIMS, Bhubaneswar- 751 019, separately in a sealed envelope superscripted as: e-Tender for Supply of **Supply of Consumables for RT PCR Machine for external project "DIMONDS" on rental basis for the dept. of Pathology at AIIMS, Bhubaneswar.** The sealed envelope should reach on or before the last date & time of submission of e-tender online, failing which the bid of the representative bidder will summarily be rejected.



- a. Earnest Money Deposit (Bid Security) amounting to Rs. 17000/-
- b. Undertaking for acceptance of all Terms & Conditions as per **Annexure-I**.
- c. Notarized affidavit on Indian Non-judicial stamp paper of Rs. 10/- as per **Annexure-II**
- d. Details of Make & Model of Equipment & Country of Origin without mentioning price.
- e. Technical Literature/ Catalogues & documents that are technically relevant and supportive to the bid.
- f. Manufacturer's Authorization certificate in case of authorized distributor of OEM as per **Annexure-III**.

### **1.10 Withdrawal, Substitution and Modification of Tender:**

No bid will be allowed to withdrawn in the interval between the deadline for submission of bids and expiration of the period of validity. Withdrawal of a bid during this period will result in forfeiture of the bidder's bid security (EMD).

### **1.11 Public Procurement (Preference to Make in India/MSEs/Start-ups):**

**1.11.1 Preference to Make in India products** (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020.

As the items are in GTE Exemption list (as per OM No- F4/1/2023-PPD, dated- 17-02-2025), Class-I, Class-II Local suppliers & Non-Local Suppliers will be eligible to bid.

Eligible micro and small enterprises will be allowed to participate.

Local content in the context of this policy is the total value of the item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.:

- a) 'Class-I Local Supplier' with local content equal to or more than 50%.
- b) 'Class-II Local Supplier' with local content equal to or more than 20%, but less than that applicable for Class-I Local Supplier.
- c) 'Non - Local Supplier' with local content less than that applicable for Class-II local Supplier, in (b) above.

Bids with false declarations regarding Local contents shall be rejected as unresponsive, in addition to punitive actions under the MII orders and for violating the Code of Integrity as per the Tender Document.

If a Bidder is claiming exemption (as obtained from relevant authorities) from meeting the stipulated local content on account of manufacturing the product in India under a license from a foreign manufacturer with the precise phasing of increase in local content, he must provide proof thereof.

**1.11.2 Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued 3 / 7 by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the

bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

**1.11.3 Concurrent application of Public Procurement Policy** for Micro and Small Enterprises Order 2012 and Preference to Make in India in Public procurement will be as per the guidelines laid down by the OM No.F.1/4/2021-PPD dated 18.05.2023 issued by Department of Expenditure amended from time to time.

### **1.12 Procurement outside GeM:**

As per the Circular No. F.6/18/2019-PPD issued by Ministry of Finance, Dept. of Expenditure dated **23 Jan 20** and DO No.214/CEO-GeM/2020 dated 10.11.2020 regarding procurement of goods/ services outside GeM, bidders are required to submit documents in support of their registration with GeM i.e., Unique GeM Seller Id. with their bid. ### **1.14 Evaluation of Bid:**

The contract shall be valid for a period of 1 (One) years from the date of award of contract. The contract may be extendable, subject to maximum period of 01 (One) years, on the same terms and conditions or with some addition/ deletion/ modification as mutually agreed upon by the supplier and All India Institute of Medical Sciences (AIIMS), Bhubaneswar.

Award of Bid will be guided as per Purchase preference clause under Make in India as mentioned under para 1.12 above.

## 2. GENERAL TERMS AND CONDITIONS:

**2.1** The Validity of the Bid/ Tender Document shall be for 180 Days from the Date of Opening of the Bid.

**2.2** Tenders should be quoted only by the Original Manufacturer (OEM) or their authorized distributor or selling agent, who shall submit a current authority letter in support of the same from the Original Manufacturer (OEM) concerned in the format given at “**Annexure-III**”.

Bidders are required to quote strictly as per specifications of the Equipment/ Instruments/ Apparatus/Consumables. Deviation, if any to specification, must be brought out clearly giving deviation statement as per “**Annexure-IV**” on or before the last date of Representation.

Additional features if any, should be listed separately in the offer.

**2.3** The model of the equipment offered should be brand new and should not be refurbished or obsolete, out of production for at least 10 years from the date of installation and commissioning of the Equipment.

The reagents and consumables to be supplied for running the equipment should have a life span of at least 01 year or 75% before the date of expiry whichever is more from the date of supply. Following text shall be printed or stamped in indeleible ink on label/ pack/ cartons. “**Not for Sale, For Use by AIIMS, Bhubaneswar Only.**”

### **2.4 Scope of Work:**

**2.4.1** The Equipment/ Accessories/ Consumable supplied to the buyer under this contract shall be of the best quality and workmanship and shall be strictly in accordance with the specifications and particulars contained/ mentioned in the clauses hereof. The purchaser will be entitled to reject the said Equipment/ Accessories/ Apparatus/ Articles or such portion thereof as may be discovered not to conform to the said description and quality.

**2.4.2** The supplier shall supply, install, commission and maintain the Equipment and supply the required Reagents/ Consumables/ Control / Calibrator to be provided free of cost as and when required for satisfactory testing of all the testing parameters for a period of Five years.

**2.4.3** Supplier shall provide one dedicated person contact for hands on training and to address maintenance or any other issue arises during operation of equipment.

**2.4.4** The supplier shall have to undertake the shifting of the instrument from the location of installation to another location within the premises of department as and when required by the hospital authority.

**2.4.5** The supplier should provide calibration report of the equipment as per OEM guidelines twice in a year. In case of doubt/conflict in the accuracy of the results, calibration report shall have to be submitted through third party NABL accredited competent agencies on request of the HOD of the department.

**2.4.6** The functionality and efficacy of the equipment throughout the contract period is the sole responsibility of the successful bidder. The institute will not pay anything towards repair & maintenance of the equipment during the contract period.

**2.4.7** Any up-gradation of device of the equipment or software update required for the optimum performance of the equipment shall be done by the supplier without any additional cost.

**2.4.8** The firm will lift the equipment (as the condition may be) from the hospital site at its own cost within 15 days after expiry/termination of the contract without claiming any cost.

**2.4.9** Contract may be terminated at any time without any prior notice if service of tenderer not found satisfactory.

**2.4.10** Ownership status of all movable assets created from the investments made by the Service Provider shall remain with the Service Provider.

**2.4.11** The Supplier shall not be entitled to levy any charge to the patients.

**2.5** The Bidder should state categorically whether they have fully trained technical staff for installation/ commissioning of the Equipment and efficient after sales services.

**2.6 Deleted.**

## **2.7 Twenty-four Months On-Site Warranty including Spare Parts & Labour etc.:**

**2.7.1** The Bidder will submit a written Warranty/ Guarantee from the manufacturer for 24 (Twenty-four) months On-Site Warranty including Spare Parts & Labour etc for trouble free functioning and maintenance of the facility from the date of installation & commissioning absolutely at no extra cost to the institute. It should ensure that the equipment being offered is the latest model as per the specifications and the spares for the equipment will be available for a period of at least 2 years after the warranty / guarantee period of Five Years.

**2.7.2 The supplier will guarantee One visit of Technical Support Staff every three months (4 visits in a year) for periodic/ preventive maintenance and any time for attending repairs/ breakdown calls.**

**2.7.3** The manufacturer should also give warranty/guarantee that will keep the institute informed of any up-date of the equipment over a period of next 01 years from the date of Installation & Commissioning of the equipment and undertake to provide the same to the institute at no extra cost.

**2.7.4** The supplier further warrants that the items/Stores supplied under the contract shall have no defect arising from design, materials (except when the design adopted and/ or the material used are as per the AIIMS, Bhubaneswar specifications) or workmanship or from any act or omission of the supplier that may develop under normal use of the supplied Equipment under the conditions prevailing in India.

**2.7.5** Under no circumstances the Institute will be allowed to suffer/ fail to provide required services by way of undue delay in repair/ rectification of defects in equipment by the vendor. Replacement and repair will be undertaken for the defective Equipment at no extra cost. Proper marking has to be made for all spares for identification. If at any time the equipment is beyond repair at its installation location and needs to be taken to vendor's Authorized Service Centre for repair, a backup/ stand by equipment must be provided subject to other administrative formalities.

Replacement will be undertaken for the defective Reagents/ Chemicals/ Consumables at no extra cost. Proper marking has to be made for all items for identification.

**2.7.6** Conditional warranty like mishandling, manufacturing defects etc. is not acceptable.

## **2.8 Uptime Guarantee & Downtime Penalty Clause:**

**2.8.1** The firm will be required to guarantee that the equipment including the accessories will be maintained in good working condition for a period of 347 days out of a period of 365 days (i.e. 95% uptime on yearly basis throughout the warranty period as well as during the service contract period).

**2.8.2** If the equipment is out of order for more than 05 hours during any day it shall be considered as one day down time. The essential period to shut down the installation entirely or partially should also be included in the down time if it exceeds 02 days while calculating the 95% guaranteed uptime.

**2.8.3** Upon receipt of notice from the buyer, the supplier shall, within 48 hours on a 24 X 7 X 365 basis respond to take action to repair or replace the defective Equipment/Accessories or parts thereof, free of cost, at the ultimate destination. The supplier shall take over the replaced parts/accessories/stores after providing their replacements and no claim, whatsoever shall lie on the purchaser for such replaced parts/accessories/stores thereafter. The penalty clause for non-replacement will be applicable as per tender conditions.

**2.8.4** If the supplier, having been notified, fails to respond to take action to replace the defect(s) within 48 hours on a 24 X 7 X 365 basis, the purchaser may proceed to take such remedial action(s) as deemed fit by the purchaser, at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which the purchaser may have against the supplier.

**2.8.5** The firm will be required to pay a penalty of Rs. 500/- (Rupees Five Hundred only) per day for per unit in case the number of days of down time in each period of 365 days is more than the downtime permissible which is to be calculated as defined above and the delay for not bringing the equipment in functioning order is in any way directly, even partially, attributable to the supplier OR the warranty period will be extended double the down time by the vendor for every day of delay occurred.

**2.9** The Supplier along with its Indian Agent shall ensure continued supply of the reagents, chemicals, consumables, spare parts for the machine(s) and Equipment to the purchaser during the Contract Period.

**2.10 Fall Clause:** If at any time during the execution of the contract, the Manufacture/ Distributor/ Dealer reduces the sale price or sells or offers to sell such stores/items, as are covered under the contract, to any person/organization including the purchaser or any department of Central Government or any department of AIIMS, Bhubaneswar/ other INI/ PSUs at a price lower than the price chargeable under the contract during the Currency of the contract, they will forthwith notify AIIMS, Bhubaneswar. The difference in cost due to such reduction or sale or offer of sale would be refunded by the bidder to AIIMS Bhubaneswar, if the contract has already been concluded or AIIMS Bhubaneswar will deduct from the pending bills/Performance Security Deposit to recover the loss to the Government.

## **2.11 DELIVERY OF THE ACCESSORIES/APPARATUS:**

**2.11.1** The Delivery of Equipment/ Instruments/ Accessories/ Apparatus/ Consumables/ Chemicals/ Reagents should be made in good condition at the Central Stores, AIIMS, Bhubaneswar campus or place indicated in the Supply Order by the bidder at their own cost. AIIMS Bhubaneswar is not liable for payments on account of Packing & Forwarding charges, Freight, Insurance and other incidental charges.

**2.11.2** The firm will be bound to:

(a) Supply of the consumable within 30 days from the date of Purchase Order/ Supply Order and

(b) Supply the reagents & consumables within 30 (Thirty) days from the date of Purchase Order/ Supply Order.

Thereafter suitable action as deemed fit, will be initiated. The institute will recover the general damages or extra expenditure incurred in the risk purchase at the risk and cost of bidder and amount paid in excess shall be deducted from their pending bills. The above shall be in addition to forfeiture of Bid Security and black listing of the firm depending upon the circumstances of the default/ merit of the case.

**2.11.3** If the supplier fails to deliver the goods on or before the stipulated date, then Late Delivery charges at the rate of 0.5% per week or part thereof shall be levied subject to maximum of 10% of the total order

value. (Excluding the date of issue of Supply Order / acceptance letter and date of delivery). Purchaser may also resort to termination of the Supply Order & even Tender at any time after expiry of the allowable period for supply of the materials.

**2.11.4** Part/Partial supply will not be accepted. For any part/ partial supply, the total quantity should be completed within given delivery period. However, Part Billing is strictly prohibited.

**2.11.5** The firm shall supply the equipment/ consumables/ reagents/ chemicals with proper packing and marking for transit so as to be received at destination free from any loss or damage.

**2.11.6** The equipment/ consumables/ reagents/ chemicals should be adequately covered under transit insurance at the risk and cost of the bidder.

**2.12 Option clause:** The purchaser reserves the right to place orders for additional quantity up to 25-30% of the originally contracted quantity at any time at the same rate and terms of the contract during the currency of the contract.

**2.13** The Director, AIIMS Bhubaneswar has full authority to take into account the performance of manufacturer/authorized dealer or distributor/ bidder and they should submit latest performance certificate from any other Govt. Hospitals/ Institutions/ PSUs to testify the proper dealing & performance as well as installation and maintenance of equipment.

#### **2.14 INSPECTION OF SUPPLIES:**

Inspection will be done by the duly constituted committee members nominated by Director, AIIMS, Bhubaneswar and or his authorized representatives in AIIMS, Bhubaneswar premises at designated place.

#### **2.15 PAYMENTS:**

- 100% Payment shall be released after successful & satisfactory delivery of the ordered goods against a satisfactory inspection report by the User Department, execution of contract agreement and after submission of Performance Security Deposit by the Supplier/ Vendor.
- For processing the payment, the supplier has to submit three copies of Invoice along with receipted challan copy and other relevant papers like Lorry Receipts etc.
- All payments shall be made in Indian Rupees only.

#### **2.16 PERFORMANCE SECURITY DEPOSIT:**

**2.16.1** The successful Bidder will be liable to deposit 5% of value of the Contract i.e. value of tentative One year Plus 2 Months requirement of consumables, as Performance Security Deposit in favour of "AIIMS, Bhubaneswar" by way of "Irrevocable Performance Bank Guarantee" or FDR (duly endorsed in favor of AIIMS Bhubaneswar) from a Nationalized /Commercial Bank. These instruments are subject to verification from issuing bank before its acceptance by the authorities.

**2.16.2** The Performance Security should be valid for 14 months from date of supply, which is refundable after 2months of expiry of the contract of 01 (One) years subject to successful fulfilment of terms and conditions and on receipt of requisite "No Dues Certificate" from the concerned Departments /authorities. While making such instruments as PSD, bidders may take care of the period of coverage in the instrument as stated above.

**2.16.3** The Security Deposit is liable to be forfeited if the bidder withdraws or impairs or derogates the bid in any respect.

## **2.17 DISPUTES AND ARBITRATION:**

All disputes or differences arising during the execution of the contract shall be resolved by the mutual discussion, failing which the matter will be referred to an Arbitrator who will be appointed by the Director, AIIMS Bhubaneswar for arbitration for settlement of disputes in accordance with Arbitration & Conciliation Act 1996 or its subsequent amendment, whose decision shall be binding on the contracting parties.

## **2.18 LAW GOVERNING THE CONTRACT AND JURISDICTION.**

The contract shall be governed under Indian Contract Act 1872 and instructions thereon from the government of India. The Court of Bhubaneswar shall alone have jurisdiction to decide any dispute arising out of or in respect of the contract.

## **2.19 POWER TO IGNORE MINOR DEVIATIONS:**

AIIMS, Bhubaneswar reserves right to ignore any trivial nature of deviation(s) in tender documents as decided by the competent authority while processing the tender. The Institute may also seek any clarification/ documents to substantiate the claim of the bidder at the later stage if felt necessary. However, the bidder can't claim it as a matter of right and will be bound to comply the Terms & Conditions of the tender without citing the ground of trivial deviation/ seeking of the clarification/ documents in support of the cancellation of his/ her bid.

## **2.20 OTHERS: -**

**2.20.1** After due evaluation of the bid, Institute will award the contract to the responsive Bidder who has quoted Lowest Cumulative Unit Price of all consumables including GST as per Financial Bid (Part-I).

**2.20.2** At the time of awarding the contract, the tendered quantity can be increased or decreased by 25-30 percent for ordering if so warranted.

**2.20.3** The Bidder shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other agency(ies) without prior written consent of the Director, AIIMS, Bhubaneswar. If it is found that the firm has given sub-contract to another Agency, the contract shall stand cancelled & the performance security deposit of such Bidder shall be forfeited by AIIMS, Bhubaneswar.

**2.20.4** The AIIMS Bhubaneswar shall not be responsible for any financial loss or other damage or injury to any item or person deployed/ supplied by the Supplier Agency during the course of their performing the duties to this office in connection with purchase order/ supply order for supplying, installation & commissioning of ordered Equipment/ Accessories/ Items at AIIMS Bhubaneswar.

**2.20.5** If the bidder denies/ fails to execute the contract/ order after being awarded for the same or to submit the Performance Security, the bid security (EMD) shall be forfeited and the vendor will be debarred for a period of two years from participating in future tenders of the Institute.

## **2.21 Debarment from bidding:**

**(i)** A bidder shall be debarred if he has been convicted of an offence-

**(a)** under the Prevention of Corruption Act, 1988; or

**(b)** the Indian Penal Code or any other law for the time being in force, for causing any loss of life or property or causing a threat to public health as part of execution of a public procurement contract.

**(ii)** A bidder debarred under sub-section (i) or any successor of the bidder, shall not be eligible to participate in a procurement process of any procuring entity for a period not exceeding three years

**(iii)** A procuring entity may debar a bidder or any of its successors, from participating in any procurement process undertaken by it, for a period not exceeding two years, if it determines that the bidder has breached the code of integrity. The Ministry/Department will maintain such list which will also be displayed on their website.

**(iv)** The bidder shall not be debarred unless such bidder has been given a reasonable opportunity to represent against such debarment.

**(v)** As per OM no. F-1/20/2018-PPD issued by Ministry of Finance, Dept. of Expenditure dated 02 Nov 2021 & OM no. F1/20/2018-PPD, dated 02 Aug, 2022 regarding guidelines on debarment of firms from bidding also applicable.

## **2.22 Code of Integrity:**

No official of the bidder shall act in contravention of the codes which includes

Supply of ordered items should always be at Central Stores, AIIMS, Bhubaneswar.

#### 5. Penalty & Recovery of Sums Due:

(i) If the Vendor/ Supplier/ Firm/ Company fails to deliver the **CONSUMABLES FOR (EQUIPMENT NAME WITH MAKE & MODEL)** or replace the defected/spurious/expired/ soon to expire items within the stipulated date & time, a penalty on weekly basis for delay @ 0.5% of total order value per week or part thereof (date of purchase order and date of delivery being excluded), subject to maximum of 10% of total order value. Such penalty (L.D.) shall be deducted from the Rate Contract holder/Agency/Authorized Dealer's pending bills or Performance Security.

(ii) On failure by the Vendor/ Supplier/ Firm/ Company to supply the desired **CONSUMABLES FOR (EQUIPMENT NAME WITH MAKE & MODEL)**, if the items are procured from other sources, any extra cost incurred/paid on account of such other sources procurement by AIIMS, Bhubaneswar will be recovered from any of his subsequent/pending bills or Performance Security Deposit. In case of change in Local Authorized dealer by Rate Contract holder, any pending purchase order should be completed within stipulated delivery period. LD recoverable on such non-compliance shall be recovered from pending bills or Performance Security.

(iii) In case the sum of the above is insufficient to cover the full amount recoverable, the Rate Contract holder/Agency/Authorized Dealer shall pay to the client, on demand of the remaining balance due.

6. Upon selection of the Vendor/ Supplier/ Firm/ Company, if at any stage, the documents furnished by him/her is found to be false or the quality of the items are found to be poor quality/different specifications, or rates are higher than the quoted rate it would be deemed to be a breach of terms of contract and the contract shall be cancelled and performance security shall be forfeited.

7. The rate quoted by the Vendor/ Supplier/ Firm/ Company or which have been approved after due negotiation by the AIIMS, Bhubaneswar shall remain valid throughout the period of contract and the request to increase the rates for any or all items, during the currency of contract, shall not be entertained at any stage.

#### 8. Submitting of Contract:

The Vendor/ Supplier/ Firm/ Company shall not be allowed to transfer, assign, pledge or subcontract its rights and liabilities under this contract to any other Vendor/ Supplier/ Firm/ Company without prior written consent of the AIIMS, Bhubaneswar. If it is found that the Vendor/ Supplier/ Firm/ Company has given sub-contract for supply of **CONSUMABLES FOR (EQUIPMENT NAME WITH MAKE & MODEL)** for AIIMS, Bhubaneswar on the basis of Purchase Order, the contract shall stand cancelled & the performance security shall be forfeited.

9. AIIMS Bhubaneswar shall not be responsible for any financial loss or other damage or injury to any item



supplied or person deployed by the vendor in the course of their performing the duties in connection with purchase order/supply order.

#### **10. Fall Clause:**

(i) Prices charged for supplies under Rate Contract by the supplier should in no event exceed the lowest prices at which he quotes/bids to sell or sells the stores of identical description to any other Govt. hospitals/renowned private hospitals during the period of the contract.

(ii) If at any time during the period of contract, the prices of the Rate Contract items are reduced or brought down by any law or Act of the Central or State government, the supplier shall be bound to inform Purchasing Authority immediately about such reduction in the contracted prices, in case the supplier fails to notify or fails to agree for such reduction of rates, the Purchasing authority will revise the rates on lower side. If there is a price increase for any product after quoting the rates, the bidder will have to supply the item as per quoted rates. This Client will not accept any higher rates after wards.

(iii) If at any time during the period of contract, the supplier quotes the sale price of such goods to any other Govt. hospitals/renowned private hospital at a price lower than the price chargeable under the rate contract he shall forthwith notify such reduction to Purchasing Authority and the prices payable under the Rate contract for **CONSUMABLES FOR (EQUIPMENT NAME WITH MAKE & MODEL)** supplied from the such date shall stand correspondingly reduced as per above stipulation.

11. The Competent Authority of AIIMS Bhubaneswar reserves the right to relax/withdraw any of the terms and conditions mentioned in the Rate Contract, in doing so if it is in the interest of the AIIMS Bhubaneswar. If at any time during the period of this contract, the client feels that performance of this contract is not beneficial to it, the Director, AIIMS, Bhubaneswar reserves the right to terminate this contract without assigning any reasons.

12. **Force Majeure:** If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, exception, epidemics, quarantine restriction, strikes lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by the second party to the client within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance and deliveries have been so resumed or not shall be final and conclusive.

Further, if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, AIIMS, BBSR shall be at liberty to terminate the contract.

13. Any complementary scheme offered by the Manufacturer shall be provided to the AIIMS Bhubaneswar with no additional cost.

#### **14. Price List & Implementation of GST:**

(i) The **CONSUMABLES FOR (EQUIPMENT NAME WITH MAKE & MODEL)** to be supplied by the Vendor/ Supplier/ Firm/ Company under Rate Contract basis is attached herewith as (Annexure- A).

(ii) **GST:** In the event of changes in GST rates, if there is any reduction in the basic price structure, the same must be intimated to AIIMS, Bhubaneswar with details. The Vendor is also to pass the input credit as per the following Anti Profiteering clause of GST to AIIMS, Bhubaneswar by way of commensurate reduction in the prices. In the event of increase in price, detailed justification and supporting evidence to be submitted for the consideration of AIIMS, Bhubaneswar.

15. **Payments:**

(a) Order shall be issued for tentative **Quarterly/ Six** months' requirement on actual need basis. Bills in triplicate for the tests carried out for valid donations performed by the Rate Contract holder duly certified by the User Department, should be raised for payment. Payment shall be released after deducting TDS as per Income Tax Rules and any other deductions as per Government rules only after it is ensured that the quantity and quality of items supplied are to the entire satisfaction of this office and accepted. If any item is found to be defective, or not of the desired quality, the same shall be replaced immediately, for which no extra payment shall be made by AIIMS, Bhubaneswar.

(b) The bills raised by the Vendor/ Supplier/ Firm/ Company should have all tax registration numbers printed on bill. The bill shall be signed by the authorized signatory of the firm.

16. **Performance Security:** The Vendor/Agency/Authorized Dealer have to furnish Performance Security of Rs. .... (Rupees.....) (**Performance Security Amount as per Award of Contract**) in shape of FDR/ TDR/ Irrevocable Bank Guarantee in the name of All India Institute of Medical Sciences, Bhubaneswar. The Performance Security should be kept valid for 14 months i.e. One years + Two months after completion of obligations under the contract.

17. Arbitration: If any difference arises concerning this agreement and its interpretation, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, Sole arbitrator will be appointed by the Director, AIIMS Bhubaneswar in accordance with the Arbitration & Conciliation Act 1996 or its subsequent amendment. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1996 and the rule framed there under and in force shall be applicable to such proceedings.

18. **Insolvency etc.:** In the event of the Rate Contract holder/Agency/Authorized Dealer being adjudged insolvent or having a receiver appointed for it by a court or any other under the Insolvency Act made against them or in the case of a company the passing any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the firm failing to comply with any of the conditions herein specified AIIMS, Bhubaneswar shall have the power to terminate the contract without any prior notice.

19. **Right to call upon information regarding status of contract:** The AIIMS, BBSR will have the right to call upon information regarding status of contract at any point of time.

20. **Legal Jurisdiction:** The agreement shall be deemed to have been concluded in Bhubaneswar, Odisha and all obligations here under shall be deemed to be located at Bhubaneswar, Odisha and Court within Bhubaneswar, Odisha will have Jurisdiction to the exclusion of other courts.

21. **Obligation of the Vendor:** The Vendor shall ensure full compliance with tax laws of India with regard to this Contract and shall be solely responsible for the same. The vendor shall keep AIIMS, Bhubaneswar fully indemnified against liability of tax, interest, penalty if any imposed by any statutory authority of this contract and paid on behalf of the vendor.

22. In addition to above, all other terms and conditions express and implied and essential for execution of this agreement as per Tender enquiry document will form part of this agreement.
