

No candidates will be allowed to appear for the Interview without NOC as per the conditions of the advertisement.

3. The Candidates, who have opted for the Online (Video Conferencing) mode of interview will receive the meeting link and necessary credentials separately via their registered email address, as provided in the application form, in due course of time.
