PROCEDURE FOR RECRUITMENT

2. The above position will be filled purely on temporary CONTRACT appointment basis.
3. The rates of emoluments/stipend shown in this advertisement are as per guidelines and as per the sanction.
4. Age relaxation is admissible in respect of SC/ST/OBC/PWD candidates as per Government rules.
5. Cut-off date for age limit will be the date of Walk-in-Interview Video Conferencing i.e., date of interview.
6. Qualification and experience should be in relevant discipline/field and from an Institution of repute. Experience should have been gained after acquiring the minimum essential qualification.
7. Mere fulfilling the essential/educational qualification does not guarantee the selection.
