- I. The quotation duly filled up with the schedule of quantities along with all necessary documents, in a sealed envelope superscripting the name of work shall be submitted to the office of the Executive Engineer(Electrical), Room No. 327, 3rd floor, Academic building, AIIMS, Bhubaneswar, At-Sijua, Patrapada, Pin-751019 up to 3:00 PM on 18.11.2025 and the same will be opened at 3:30 PM on 19.11.2025 at the office of the Executive Engineer (Elect), 3rd floor, Academic building, AIIMS Bhubaneswar. If the last date of submission is a holiday then the last date will be considered as the next working day. However, the opening time will remain unchanged.

II. Bidders who fulfill the following requirements shall be eligible to apply:

The consulting firms/Institutions/Govt. approved testing agencies having satisfactorily completed **Similar Work(s)** & shouldn't have been debarred/imposed penalty due to slow progress for the execution of work with Central Government/State Government Department/ Central Autonomous Body/ State Autonomous Body/ Central Public Sector Undertaking/ State Public Sector Undertaking/ City Development Authority/ Municipal Corporation of City formed under any Act by Central/ State Government and published in Central/ State Gazette during last seven years ending previous day of last date submission of quotation.

III. Similar work means:

“Supply, Installation, Testing and Commissioning of IP based CCTV System”

- IV. Intending Bidder(s) is/are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids, the means of access to the site and in general shall themselves obtain all necessary information as to risks, contingencies, and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed.
- V. Works Should be executed as per CPWD specifications.
- VI. The department shall not supply any materials for the work. All T&P for the work shall be arranged by the contractor.
- VII. Payment shall be made as per rule and as per actual measurement at the site after completion of work.
- VIII. Payment will be made after statutory deduction as per prevailing rules.
- IX. The time allowed for completion of job shall be **30 (Thirty-Days)** from the date of award of work.

X. The Engineer-in-charges reserves the right to accept in full or in part or reject any bid and to annul the process and reject all bids at any time without assigning any reason or incurring any liability to the bidders. This notice may also be seen at website www.aiimsbhubaneswar.nic.in.

XI. Goods and Services Tax (GST).

- (a) GENERAL REMARKS ON TAXES & DUTIES: In view of GST Implementation from 1st July 2017, all taxes and duties including Excise Duty, CST/VAT, Service tax Entry Tax, and other indirect taxes and duties have been submerged in GST. Accordingly, reference of Excise Duty, Service Tax, VAT, Sales Tax, Entry, or any other form of indirect Tax except of GST mentioned in the bidding document shall be ignored.
- (b) Bidders are required to submit a copy of the GST Registration certificated while submitting the bids wherever GST (CGST & SGST/UTGST or IGST) is applicable.
- (c) "GST shall mean Goods and Services Tax charged on the supply of material(s) and services. The term 'GST' shall be construed to include the integrated Goods and Services Tax (hereinafter referred to as "IGST") or central Goods and Services Tax (hereinafter referred to as "CGST") or State Goods and Services Tax (Hereafter referred to as "SGST") or Union Territory Goods and Services Tax (hereinafter referred to as "UTGST").
- (d) **Quoted price/rate(s) should be inclusive of all taxes and GST** (i.e. IGST or CGST and SGST /UTGST applicable in case of interstate supply or intrastate supply respectively and cess on GST if applicable) on the final service. The Technical Bid and the financial Bid should be sealed by the bidder in 02 (Two) separate Covers superscripted with name of work in both the envelopes as **"Technical Bid" and "Financial Bid" respectively. XV. First the Technical Bid(s) shall be opened on **18.11.2025 at 15:30 Hours**. Financial bid of bidders will be opened, whose Technical bid is found to be eligible. After the evaluation of the bid(s), AIIMS

Bhubaneswar will be award the contract to the lowest evaluated responsive bidder.

XVI.

- a. Security Deposit 2.5% of the gross amount of the bill shall be deducted as per GCC-2020 from the Bills of the Contractor.
- b. The Income Tax as applicable shall be deducted from the Bill unless exempted by the Income Tax Department.
- c. The quoted Rates shall be inclusive of GST.
- d. Labour CESS @ 01% will be deducted from the Bill.
- e. Water charges @ 1% of the gross bill amount will be deducted if water supply is taken from AIIMS departmentally.
- f. Electrical charges as per actual meter reading shall be deducted from the bill. If connection is taken directly without installation of meter with prior permission from Executive Engineer (Electrical), then amount as per the usage shall be deducted from the gross bill amount as suggested by Executive Engineer (Electrical).
- g. All the work shall be completed within 30 days from the date of issue of work Order by the Institute. All the aspects of safe installation shall be the exclusive responsibility of the Contractor. If the contractor fails to complete the work on or before the stipulated date, than a penalty at the Rate of 1 % per month of delay to be computed on per day basis of the total order value shall be levied subject to maximum of 10% of the total order value

SCOPE OF WORK

Project Title:

“One-Time Repairing of CCTV System for PG-IA, PG-IB, PG-II and PG-III at Housing Complex of AIIMS Bhubaneswar.”

Objective:

The scope of this work involves one-time repairing, restoration, and recommissioning of the existing CCTV surveillance systems installed at PG-IA, PG-IB, PG-II, and PG-III Blocks of the Housing Complex, AIIMS Bhubaneswar.

The work aims to bring the CCTV systems back to full operational condition by repairing, replacing, reinstalling, and configuring the required equipment and accessories, ensuring reliable monitoring and enhanced security coverage across all the blocks.

The contractor shall carry out the work in accordance with relevant standards and good engineering practices, including supply, installation, testing, and commissioning (SITC) of the required components, along with verification of system performance after completion.

Scope Includes:

A. PG-IA Block:

- Supply, installation, testing, and commissioning of 4 TB Surveillance-grade SATA Hard Disk Drive (HDD) in the existing DVR/NVR system for continuous 24×7 recording.
- Supply and laying of 3+1 Copper CCTV Cable, including saddling, clamping, and proper termination for video and power signal transmission.
- Supply, installation, and termination of BNC and DC Power Connectors for analog CCTV cameras ensuring stable connectivity.
- Supply and installation of Camera Mounting Junction Boxes, weatherproof and corrosion-resistant, suitable for indoor and outdoor cameras.
- Supply, installation, and commissioning of 20A SMPS Power Supply for DVR/NVR equipment.
- Reinstallation and alignment of existing analog CCTV cameras in provided junction boxes, ensuring correct positioning, field of view, and full operational testing.
- System testing and commissioning for complete operational functionality.

B. PG-IB Block:

- Supply, installation, and integration of 4 TB Surveillance-grade HDD in the existing DVR/NVR unit for 24×7 recording.
- Supply and laying of 3+1 Copper CCTV Cable with termination and clamping for stable connectivity.

- Reinstallation of existing Network Rack, including mounting, cable dressing, and earthing verification.

- Supply and installation of RJ-45 connectors, HDMI/VGA cables, and converters as required for display connection.
- Supply and installation of Wireless Optical Mouse for NVR control and navigation.
- Installation of Wall Mount Kit for LED/LCD Monitor, along with reinstallation and alignment of the monitor.
- Supply and installation of electrical fittings, including modular switches, sockets, MCBs, conduits, and FRLS wiring in compliance with DSR-2025.
- Final testing, integration, and commissioning of the entire CCTV system for reliable functionality.

- System testing, commissioning, and functional handover after verifying full CCTV operation and integration with existing infrastructure.

2. Completion Requirements

- All works shall be carried out with due care without causing damage to existing installations, building structures, or finishes.
- The contractor shall ensure all supplied items are brand new, of approved make, and conform to relevant IS/IEC standards.
- Testing and commissioning shall be done in the presence of the Engineer-in-Charge or his authorized representative.
- After completion, the contractor shall hand over the system in fully working condition, with all configuration files, user credentials, and operation manuals as applicable.

3. DLP/WARRANTY PERIOD

The warranty period/DLP period for the active components like CCTV camera, hard disk , network switch is 2 Years and for rest other items is 1 year.

Security deposit will be released after 1 year form the completion date.

Preamble

WHEREAS, the Principal/Owner has floated the NIQ (**AIIMS/BBSR/ENGG. / NIQ. /08/2025**) (here in after refer red to as **"NIQ/Bid"**) and intends to award, under laid down organizational procedure, contract for: **"One-Time Repairing of CCTV System for PG-IA, PG-IB, PG-II and PG-III at Housing Complex of AIIMS Bhubaneswar."** . Herein after referred to as the **"Contract"**.

AND WHEREAS the Principal/Owner values full compliance with all relevant laws of the Land, Rules & Regulations, Economic use of resources and of fairness/ transparency in its relation with its Bidder(s) and Agency(s).

AND WHEREAS to meet the purpose afore said both the parties have agreed to enter to this Agreement (hereinafter referred to as **"Pact"**), the terms and conditions of which shall also be read as integral part and parcel of the NIQ/Bid documents and Contract between the parties.

NOW, THEREFORE, inconsideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under: -

Article - 1: Commitment of the Principal/Owner.

1. The Principal/Owner commit itself to take all measures necessary to prevent corruption and to observe the following principles:
 - (a) No employee of the Principal/Owner, personally or through any of his/her family members, will in connection with the NIQ, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.

 - (c) The Principal/Owner shall endeavor to exclude from the NIQ process any person, whose conduct in the past has been of biased nature.

2. If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal Code (IPC)/Prevention of Corruption Act, 1988 (P C Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

Article - 2: Commitment of the Bidder(s)/Agency(s)

1. It is required that each Bidder/Agency (including their respective officers, employees and agents) adhere to the highest ethical standard and makes, and report to the Government/Department all suspected acts of **fraud or corruption or Coercion or Collusion** of which it has knowledge or becomes aware, during the NIQ process and throughout the negotiation or award of a contract.
2. The Bidder(s)/Agency(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the NIQ process and during the Contract execution: -

 - (c) The Bidder(s)/Agency(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/Contract(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
 - (d) The Bidder(s)/Agency(s) of foreign origin shall disclose the names and addresses of agents/representatives in India, if any. Similarly, Bidder(s)/Agency(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a NIQ but not both. Further, in cases where an agent participating a NIQ on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel NIQ for the same item.
 - (e) The Bidder(s)/Agency(s) will, when presenting his bid, disclose any and all payments he has made, is committed to, or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.
3. The Bidder(s)/Agency(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
4. The Bidder(s)/Agency(s) will not, directly or through any other person or firm indulge in fraudulent practice **means a willful misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.**
5. The Bidder(s)/Agency(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may be fall upon a person, his/her reputation or property to influence their participation in the NIQ process).

Article - 3: Consequences of Breach.

Without prejudice to any rights that may be available to the Principal/Owner under law or the Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Agency(s) and the Bidder/Agency accepts and undertakes to respect and uphold the Principal/Owner's absolute right: -

1. If the Bidder(s)/Agency(s), either before award or during execution of Contract has committed a transgression through a violation of Article-2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days notice to the agency shall have powers to disqualify the Bidder(s)/Agency(s) from the NIQ process or terminate/determine the Contract, if already executed or exclude the Bidder/Agency from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. **Such exclusion may before vigor for a limited period as decided by the Principal/Owner.**
2. **Forfeiture of Performance Guarantee/Security Deposit :** If the Principal/Owner has disqualified the Bidder(s) from the NIQ process prior to the award of the Contract or terminated/determined the Agency has accrued the right to terminate/determine the Contract according to Article-3(1), the Principal/Owner apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Performance Guarantee and Security Deposit of the Bidder/Agency.

5. It is agreed term and condition that any dispute or difference arising between the parties with regard to the terms of this Agreement/Pact, any action was taken by the Owner/Principal in accordance with this **Agreement/Pact or the interpretation thereof shall not be subject to arbitration.**

For the sake of brevity, both the Parties agree that this Integrity Pact will have precedence over the NIQ/Contract documents with regard any of the provisions covered under this Pact.
