IMPORTANT NOTES: -

1. Having been shortlisted for Document Verification does not entail any right for issuing an Offer of Appointment to the above-listed candidates. The final result will be published after document verification, and depending on the number of vacancies available.
2. The above list is purely provisional and may vary after detailed examination/verification, besides any terms and conditions of this Notification. The decision of the Competent Authority, AIIMS BBSR, in this regard shall be final.
3. All eligibility criteria and terms and conditions for determining a candidate's eligibility will be in accordance with the advertisement notice published by AIIMS Delhi for the COMMON RECRUITMENT EXAMINATION (CRE) - 2025. This includes Notice No. 278/2025 dated July 11, 2025, Corrigendum No. 17/2025 dated July 18, 2025, Corrigendum No. 18/2025 dated July 24, 2025, as well as any subsequent corrigenda or addenda published, if applicable.
4. In case any of the listed candidates is found not fulfilling any of the eligibility criteria at any stage, then his/her candidature/selection will be cancelled without giving any reason. The decision of the Competent Authority, AIIMS, Bhubaneswar in this regard shall be final.
5. The Degree/Diploma qualification as claimed by the candidate(s) should be recognised by the concerned Board/University/UGC/Government. The candidates have to submit documentary proof to the satisfaction of the authority of the AIIMS, Bhubaneswar, that the same is recognised by the Government Authority. **If anyone fails to submit documentary evidence, then his/her candidature will be cancelled without giving him/her any further opportunity. Similarly, while claiming any qualification as equivalent to a degree/diploma, the candidate also has to submit documentary proof issued by the appropriate authority.**
6. The list of candidates listed for document verification is not the common merit list and will have no bearing on seniority; the seniority will be determined as per the

common merit list of all selected candidates, irrespective of the date of joining of the candidates.

7. Candidates are requested to bring the following original documents with them, along with one additional set of self-attested photocopies as per Annexure-A.
8. Date(s) of valid OBC(NCL) certificate: Candidates applying under the OBC category must produce the valid caste certificate in the format provided by the **DoP&T vide O.M No. 36036/2/2013- Estt. (Res.) dated 30.05.2014 and further clarification issued by DoP&T OM No. 36011/1/12- Estt.(Res.) dated 14.03.2016**. The certificate must mention the non-creamy layer status of the applicant (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93-Estt. (SCT) dated 8.9.1993). The OBC applicants who belong to the 'Non-Creamy Layer' and whose caste appears in the Central List of the OBCs (notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backwards Classes available at the website <http://ncbc.nic.in>) shall be eligible to be considered under the OBC category (Validity period of OBC Certificate in respect of non-creamy layer status of the applicants as per DOPT Office Memorandum No. 36036/2/2013- Estt. (Res-I) dated 31 March 2016). **The non-creamy layer certificate should have been issued during the financial year 2025-2026 (considering income up to financial year ending on 31st March 2025) i.e. issued on or after 01st April, 2025, to the last date of application i.e 31 st July, 2025. At the time of Document Verification, the applicant must produce the applicable certificate valid for the financial year (2025-2026) and issued within the date, as mentioned above along with the old certificate and the acknowledgement slip generated while applying for the new certificate. This additional certificate (if any) must have a reference to his/her already issued original caste certificate.**
9. Date(s) of valid EWS certificate: - The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019. Application under the EWS category will be considered, subject to submission of an Income and Assets certificate on a prescribed format issued by the competent authority and subject to verification of the genuineness of the certificate by the issuing authority. In pursuance of DoP&T OM No. 36039/1/2019-Estt (Res), dated 31.01.2019, **an EWS certificate issued in the prescribed format for employment in Central Government on the basis of income of financial year 2024-2025 issued from 01.04.2025 to 31.07.2025 valid for the financial year 2025-2026 will be considered valid.**

*The language of the Certificate should be in Hindi/English Language and in the prescribed format for central Government. Candidates who fail to produce valid category certificate, OBC/EWS/SC/ST/PWBD, etc., during document verification or as and when required to produce the same, the candidature will be cancelled. Any EWS certificate issued beyond above said dates will be treated as invalid.

10. **Candidates who fail to produce a valid category certificate, OBC/EWS/SC/ST/PWBD etc., during document verification or as and when required to produce the same, the candidature will be cancelled. All candidates are advised to produce valid category certificate during the DV to avoid cancellation of candidature at any stage of the recruitment process.**

11. **Those candidates who are in Govt. Service (including AIIMS Employees) is required to produce a No Objection Certificate (NOC) for document verification; without the same, they shall not be allowed to participate in the document verification process, and their candidature will be treated as cancelled.**
12. The final selection will be purely on merit who fulfils all eligibility criteria as per the advertisement. Action as warranted under the Rules/Law will be taken in respect of those candidates found influencing the recruitment process in any manner.
