2. The candidature of the shortlisted candidates after Document Verification is purely provisional subject to verification and fulfilment of the eligibility criteria with regards to age, category, essential qualification and experience etc. as per the advertisements and Rules & Regulations of the Institute, beside the number of vacancies available.
