No candidate shall be permitted to appear for the Interview without submission of the requisite NOC, as per the conditions stipulated in the advertisement.
- Candidates applying against reserved category posts, namely SC/ST/OBC/PwBD/ EWS, are required to produce valid Caste/Category/PwBD/EWS Certificate(s) issued by the Competent Authority in the prescribed format and shall be in conformity with the instructions issued by the Government of India from time to time.
