In reference to the Advertisement issued for the recruitment to the post of **Assistant Professor (Group 'A')** in various Departments of **AIIMS Bhubaneswar Satellite Centre, Balasore**, issued vide Advertisement No. **RECT-11012/3/2025-RECU SEC (I/20637/2025)** dated **22.12.2025**, it is hereby notified that the **Interview** for selection to the aforesaid Faculty posts is scheduled to be held from **03.06.2026 to 05.06.2026**. The Interview process shall be conducted strictly in **physical (offline) mode only**.

All **Eligible/Provisional Eligible** candidates are advised to carefully go through the **"Important Note"** appended to this notification and act strictly in accordance with the instructions contained therein.

Further, the tentative schedule for **Document Verification, Reporting Time, Time Slots for the Personal Interview, and the venue(s) for Document Verification and Interview** shall be notified separately in due course through the official website of the Institute.

N.B: All candidates are advised to remain available for the entire day on their scheduled date of Interview, as the Interview process for certain Departments may extend beyond the stipulated time schedule. Further, in the event the Interview process could not be completed on the scheduled date due to administrative or other exigencies, the concerned candidates may be required to appear on the subsequent day for completion of the Interview process. Accordingly, candidates are advised to make necessary arrangements and remain available as required.

Important Note:

1. Candidates are required to produce **one set of self-attested photocopies** along with the **original documents/testimonials** before the Document Verification Committee at the time of Document Verification for verification and record purposes: –

1) **Identity Proof**

Government-issued valid Photo Identity Proof such as Aadhaar Card, PAN Card, Passport, Voter ID, Driving Licence, etc.

2) **Proof of Date of Birth**

Matriculation Certificate/Birth Certificate or any other valid document indicating the Date of Birth.

3) **Educational Qualification Certificates**

All **Marksheets and Certificates** from **Matriculation** onwards, including but not limited to:

- a) Senior Secondary Certificate;
- b) MBBS;
- c) MD/MS;
- d) DM/M.Ch./DNB;
- e) M.Sc./Ph.D.; and
- f) Any other relevant qualification certificate(s).

4) **Medical Registration Certificate**

Valid Medical Council Registration Certificate issued by the competent authority.

5) **Experience Certificate(s)** (As Applicable)

Candidates are required to produce valid Experience Certificate(s) in support of the prescribed teaching/research experience.

- a) The candidate must possess the requisite teaching and/or research experience in a recognized Institution in the concerned specialty after obtaining the qualifying degree of MD/MS or any equivalent qualification recognized as such, as prescribed in the Advertisement.
- b) The Experience Certificate must clearly indicate:
 - i. Duration of experience ("From" – "To");
 - ii. Nature of experience (Teaching and/or Research); and
 - iii. Designation/Post held.
- c) Only such teaching/research experience as recognized by the NMC (erstwhile MCI)/ Government of India shall be considered.

6) Valid **Caste/Category Certificate(s), including PwBD Certificate** (As Applicable)

- a) Candidates applying against reserved category posts, namely SC/ST/OBC/PwBD/EWS, are required to produce valid Caste/Category/PwBD/EWS Certificate(s) issued by the Competent Authority in the prescribed format.
- b) The Community/Caste mentioned in the Certificate must be clearly and legibly indicated.
- c) The OBC (Non-Creamy Layer) Certificate and EWS Certificate must be valid for the Financial Year 2025–26.

7) **No Objection Certificate (NOC)** (As Applicable)

- a) Candidates presently serving under Government Organizations, including AIIMS Bhubaneswar employees, must produce a valid **No Objection Certificate (NOC)** issued by their present employer at the time of Document Verification/Interview or as per instructions issued by the Institute from time to time.
- b) No candidate shall be permitted to appear for the Interview without submission of the requisite NOC from the employer.

8) **Affidavit**

A duly sworn Affidavit executed on Non-Judicial Stamp Paper of denomination of Rs. 20/- or above, as per the prescribed proforma attached with the notification.

9) **PowerPoint Presentation (PPT)**

Candidates are required to come prepared with a PowerPoint Presentation (PPT) strictly in accordance with the prescribed slide format enclosed with the notification.

10) **Any Other Relevant Document(s)**

Any other relevant document(s)/certificate(s) deemed necessary in support of eligibility, experience, category claim, or any other claim made by the candidate in the application form related to confirmation of the eligibility for appearing in the Interview.
