In accordance with the recommendations of the Scrutiny Committee and with the approval of the Competent Authority, the revised eligibility status of the candidates who were earlier declared ineligible and subsequently submitted representations along with supporting documents for the respective posts is hereby notified, as per the eligibility criteria prescribed in Advertisement Notice No. TEM-12/3/2025-TEM DEPT (I/21632/2026) dated 24.02.2026. Accordingly, the lists specifying the eligibility status of the candidates are annexed as under:

IMPORTANT NOTES-

- 1.** The candidature of all candidates is purely provisional and subject to detailed scrutiny and verification of original documents, fulfilment of the eligibility criteria prescribed in the advertisement, and other terms and conditions stipulated therein. The decision of the Competent Authority regarding eligibility and selection shall be final and binding.
- 2.** **The date, time, and venue of the written test/skill test, Document Verification and interview shall be notified shortly on the Institute's website and will also be communicated to the registered e-mail IDs of the candidates.**
- 3.** **A Skill Test shall be conducted for the post of Data Entry Operator (DEO).** The prescribed skill test norms are as follows:

- Computer typing speed of 35 words per minute (w.p.m.) in English or 30 words per minute (w.p.m.) in Hindi.
- Duration of the test: 10 minutes.
- The prescribed speed of 35 w.p.m. / 30 w.p.m. corresponds to 10,500 Key Depressions Per Hour (KDPH) / 9,000 KDPH, respectively, calculated on an average of five key depressions per word.

4. Only those candidates who qualify in the Skill Test for the post of Data Entry Operator shall be called for the interview. The schedule for the Skill Test shall be notified separately on the Institute's website in due course.

5. The final selection of candidates shall be made strictly on the basis of merit, subject to the fulfilment of all eligibility conditions prescribed in the advertisement and successful performance in the interview/selection process. Any attempt by a candidate to influence the recruitment process in any manner shall lead to appropriate action as per applicable Rules/Law.

6. While every care has been taken in preparing the list of eligible candidates, AIIMS Bhubaneswar reserves the right to rectify any inadvertent error, omission, or typographical/printing mistake at any stage of the recruitment process.
