5. The list of candidates listed after document verification is not the common merit list and will have no bearing on seniority, the seniority will be determined as per the common merit list of all selected candidates irrespective of the date of the joining of the candidates

Those candidates whose name in the aforesaid list have to meet their eligibility criteria as per the advertisement and Offer of Appointment will be issued as per the vacancies available of the advertised posts and their candidature is purely provisional.
