The interested publishers or their authorised dealers/distributors are required to submit the technical and financial bids separately. The bids in sealed cover-I containing “**Technical Bid**” and sealed Cover-II containing “**Financial Bid**” should be placed in a third sealed cover super scribed “**Tender for Online Medical Journals for the year 2017 (01 Jan 2017 to 31 Dec 2017)**” and should reach the office of “**The Administrative Officer, AIIMS, Bhubaneswar, Sijua, Dumduma, Bhubaneswar-751019** on or before (date) **15-11-2016 by 12.00 pm**. The bids received after the due date and time will not be entertained whatsoever may be the reason. The technical bids shall be opened on same day at 3.00 pm at AIIMS, Bhubaneswar. In the event of any of the above mentioned date being declared as holiday/close day, the tenders will be opened on the next working day at the appointed time. The date of opening of financial bid of technically qualified agencies will be announced later.

**TERM & CONDITIONS FOR SUPPLY OF ONLINE MEDICAL JOURNALS  
TO AIIMS, BHUBANESWAR**

1. The tender document can be downloaded from website : [www.aiimsbhubaneswar.edu.in](http://www.aiimsbhubaneswar.edu.in) . The tenderer should enclose the demand draft/pay order for Rs 2000.00 (Rupees Two Thousand Only) drawn on any Nationalised/Scheduled Bank in favour of ‘**AIIMS, Bhubaneswar**’ towards non-refundable tender fee payable at Bhubaneswar not later than the date of **15-11-2016** along with the bid in the cover-**I** containing ‘Technical Bid’.
2. The interested publishers/Firms/Suppliers are required to supply the technical and financial bids separately in format enclosed. The bids in sealed cover **I** containing “**Technical Bid**” and sealed cover **II** containing “**Financial Bid**” should be placed in a third sealed cover super scribed “**Tender for On line Medical Journals**” should reach AIIMS, Bhubaneswar by or before 12.00 PM on **15-11-2016**. The technical bid should be opened on same day at 3.00 PM at AIIMS, Bhubaneswar in presence of the bidders or their authorised representatives who choose to remain present. The tender received after due date and time will be rejected and no claim shall be entertained what so ever may be the reason.
3. The pre bid conference would be held on **20-10-2016** at 3 PM in the **Academic Block, 1<sup>st</sup> Floor , AIIMS, Bhubaneswar**. All firms representative who are attending the pre bid meeting shall produce an authorisation from their firms on the firms letter head. They are required to put their query in writing before the committee.
4. All the duly filled/completed pages of the tender should be given serial/page No on each page and signed by the owner of the firm or his authorised signatory. In case the tenders are signed by the authorised signatory, a copy of the power of attorney for authorisation may be enclosed along with the tender. A copy of the terms and conditions shall be signed on each page and submitted with the Technical Bid as a token of acceptance of the terms and conditions. Tender with unsigned pages/incomplete/partial/part of tender if submitted will be rejected out rightly.
5. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is in sufficient, a separate sheet duly signed by the authorised signatory may be attached. No overwriting or cutting is permitted in the technical bid as well as financial bid unless authenticated by the full signature of the bidder. Any omission in filling the columns of financial bid form (Schedule of rates) shall debar a tender from being considered. Rates should be filled in the schedule and must be duly attested by full signature of the tenderer. The corrections made by using fluid and overwriting will not be accepted and the tender will be rejected.

6. The bidder shall pay Rs 2,00,000/- (Rupees Two Lakh only) as bid security (EMD) along with the technical bid in the form of FD/TD/CD in favour of 'AIIMS, Bhubaneswar' drawn on any Nationalised/Scheduled Bank payable at Bhubaneswar and it must be valid for six months. Bids received without EMD shall stand rejected and thus shall not be considered for evaluation etc at any stage. The original EMD will be put in cover 1 containing technical bid :-

(a) The Public Sector Undertaking of the Central/State Govt. are exempted from furnishing Earnest Money along with tender.

(b) Earnest Money deposited with AIIMS, Bhubaneswar in connection with any other tender enquiry even if for same/similar materials/stores by the tenderer will not be considered against this tender.

7. The Bid security (EMD) without interest shall be returned to the unsuccessful bidders after finalization of contract with the successful bidder.

8. The names of successful bidders will be displayed on the website of the institute [www.aiimsbhubaneswar.edu.in](http://www.aiimsbhubaneswar.edu.in) within 7 days from the date of opening of Technical Bid.

9. The successful bidders are required to furnish the performance security deposit as per Clause 21 of contract in the form of FD/TD/BG of any nationalised bank in favour of AIIMS, Bhubaneswar & payable at Bhubaneswar only. The EMD deposited by successful bidder may be adjusted towards security deposit as demanded above. If the successful bidder fails to furnish the full security deposit or difference amount between security Deposit and EMD within 15(fifteen) days after the issue of Supply Order, his bid security (EMD) shall be forfeited unless time extension has been granted by AIIMS, Bhubaneswar.

10. Security money will be returned after six months of successful supply of journals to the Institute i.e. getting a clearance certificate from the Central Library :-

(a) The EMD shall be forfeited if successful bidder fails to supply the journals in stipulated time or fails to comply with any of the terms & conditions of the contract or fails to sign the contract.

(b) The bid shall be valid and open for acceptance of the competent authority for a period of 180 (one hundred eighty) days from the date of opening of the tenders and no request for any variation in quoted rates and withdrawal of tender on any ground by bidders shall be entertained.

(c) To assist in the analysis, evaluation and computation of the bids, the competent authority may ask bidders individually for clarification of their bids. The request for clarification and the response shall be in writing but no change in the price or substance of the bid offered shall be permitted.

11. After evaluation, the purchase order shall be awarded normally to the Agency fulfilling all the conditions and who quoted the lowest rate as per financial bid after complying with the all the Acts/provisions stated/referred to for adherence in the tender.

12. The competent authority of AIIMS, Bhubaneswar reserved all rights to accept or reject any/ all tenders without assigning any reason. It can also impose/relax any term condition of the inquiry after due discussion in pre bid conference. This will be communicated to all tenderer through web- site of this Institute. AIIMS, Bhubaneswar also reserves the right to reject any bid which in his opinion is non- responsive or violating any of the conditions/specifications without any liability to any loss whatsoever it may cause to the bidder in the process.

13. Tender must be submitted on the prescribed Tender Form otherwise tender will be cancelled straightway.

14. The tender form is not transferable.

15. Canvassing in any form is strictly prohibited and the tenderer who are found canvassing are liable to have their tenders rejected outright.

16. The successful bidder shall at all times agree to indemnify and keep indemnified the purchaser against all losses, damages which may arise in respect of action/inactions of such bidders or breach of any terms of this tender by such Bidder. All claims regarding indemnity shall survive the termination of the contract with such Bidder.

### **Financial Bid**

17. Financial Bid will be quoted only in INR.

18. Cost of the journals including Service Charge if any and applicable taxes will be shown separately.

19. The Successful bidder is required to execute a Contact agreement within 15 days of opening the financial bid/issue of the acceptance Letter.

### **Payment**

20. L1 will be decided on basis of total cost of all the journals and Service Charge if any. Taxes will be applicable as per Govt. norms.

21. Order value of one month journal will be paid as advance after receipt Performance Security in shape of FD/TD/BG of the equal amount. The value of materials supplied will be paid on monthly basis. The advance will be finally adjusted from the bills of December 2017. The performance security (FD/TD/BG) should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations.

22. All payments will be made in INR.

23. Medical journals (Indian & Foreign) will be accepted only after the inspection by the Chairman, Library Committee or any officer authorised by him.

## **Supply of Journals**

24. The supplier should inform the time gap for commencement of delivery of the journal (Indian & Foreign) from the date of order.
25. The vendor must supply all the subscribed titles of the journals including Indian & Foreign publications. Part supply of on line journals will not be accepted.
26. The vendor must follow up the delayed/missing issues from the publishers within One week of the expected date with due intimation to the Library. Refund for all the delayed/missing issues of the journals must be made before final settlement of the advance.
27. The vendor must provide periodic supply status of the journals to the library at regular interval of one month.
28. All supplies to start on **1<sup>st</sup> Jan 2017** and completed by **31<sup>st</sup> Dec 2017**.
29. In case of delay, 0.5% per week subject to 10% maximum will be charged as late delivery charge. Due to any delay or cessation of supply of issue on line beyond a reasonable period will invite forfeiture of security deposit.
30. The vendor is bound to provide print/hard copy of journal which are freely available with the on line journals without charging additional service charges.
31. The vendor must subscribe Indian/Foreign journals in the name of **“AIIMS, Bhubaneswar”**.
32. The vendor must activate online journals subscribed on behalf of Central Library and provide IP address to access user name and password within the date of the activation/subscription.
33. The vendor must develop a library portal/webpage enlisting all available online periodicals (free and subscribed) to enable access and information. It must be ensured that all the online periodicals can be accessed through the same portal/webpage.
34. The publisher should submit at least 5 samples of such library portals/webpage developed along with Technical Bid.
35. The vendor shall provide technical support and ensure smooth accessing for online periodicals. In case of any problem, the supplier should provide technical support to crease out problems within two working days.
36. The vendor must provide a search facility with respect to the title listing (A to Z listing) Publisher Index, Subject Index to simplify search for online journals.
37. The vendor must supply the archive journals as per the publisher norms without any additional charge.
