The date of opening of financial bid of technically qualified agencies will be announced in the official website of AIIMS, Bhubaneswar. No paper publication shall, however be made for Financial Bid.

(A) Information and Conditions relating to Submission of Bids

1. The tender document containing eligibility criteria, scope of work, terms & conditions and draft agreement can be downloaded from website www.aiimsbhubaneswar.edu.in. Those who download the tender document from Website should enclose a Demand Draft/Pay Order for Rs 2100/- (Rupees two Thousand one hundred only) (including VAT 5%) in favour of "AIIMS, Bhubaneswar", payable at Bhubaneswar, not later the date of 14th day, along with their bid in the Cover-I containing " Technical Bid" .
The fee is non-refundable.
2. The interested firms/suppliers are required to submit the Technical and Financial Bids separately in the format enclosed. The bids in sealed Cover-I containing "Technical Bid" and sealed Cover-II containing "Financial Bid" should be placed in a third sealed cover super scribed "Tender for SITC of LED signage made up of LED Lit Acrylic Letters" should reach AIIMS, Bhubaneswar by or before 13th October 2014 at 03.00 PM. The Technical bids shall be opened on same day at 03.30 PM at AIIMS, Bhubaneswar in presence of the bidders or their authorized representatives who choose to remain present. The Tenders received after due date & time will be rejected and no claim shall be entertained whatsoever may be the reason.
3. The tenderers are required to submit their query in writing before 13th October 2014 to Admin Officer, AIIMS, Bhubaneswar, if any.
4. All the duly filled/completed pages of the tender should be given serial /page number on each page and signed by the owner of the firm or his Authorized signatory. In case the Authorized signatory signs the tenders, a copy of the power of attorney/authorization may be enclosed along with tender. A copy of the terms & conditions shall be signed on each page and submitted with the technical bid as token of acceptance of terms & conditions. Tender with unsigned pages/incomplete/partial/part of tender if submitted will be rejected out rightly.
5. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Technical Bid as well as Financial Bid unless authenticated by full signature of Tenderer. Any omission in filling the columns of Financial Bid form (Schedule of Rates) shall debar a tender from being considered.

Rates should be filed up carefully by the tenderer. All Corrections in this schedule must be duly attested by full signature of the tenderers. The corrections made by using fluid and overwriting will not be accepted and tender would be rejected.

6. The Tenderer shall pay an amount of Rs 50,300/- as Bid Security (EMD) along with the Technical Bid in the form of BG in favour of "AIIMS, Bhubaneswar" drawn on Scheduled / Nationalize Bank and payable at Bhubaneswar and must be valid for (3) Three month. Bids received without EMD shall stand rejected and thus shall not be considered for evaluation etc at any stage. The original EMD will be put in cover-I containing Technical bid.
7. The bid security (EMD) without interest shall be returned to the unsuccessful Tenderers after finalization of contract. The EMD of successful bidder shall be returned in furnishing of performance security.
8. The successful Tenderers have to constitute a contract on Indian non judicial stamp paper of Rs.100/- (Rupees one hundred only) and also required to furnish the Performance Security 5% of contract value in the form of FDR of Scheduled/ Nationalize bank pledged in favour of AIIMS, Bhubaneswar & payable at Bhubaneswar only, with validity up to 60 days beyond all contractual obligations. If the successful tenderer fails to furnish the full performance security within 15 (fifteen) days after the issue of Letter of Award of Work, his bid security (EMD) shall be forfeited unless time extension has been granted by AIIMS, Bhubaneswar.
9. The EMD shall be forfeited if successful bidder fails to supply the Equipment item in stipulated time or fails to comply with any of the terms & conditions of the contract or fail to sign the contract.
10. The bid shall be valid and open for acceptance of the competent authority for a period of 180 (One Hundred Eighty) days from the date of opening of the tenders and no request for any variation in quoted rates and / withdrawal of tender on any ground by Tenderer shall be entertained.
11. To assist in the analysis, evaluation and computation of the bids, the Competent Authority, may ask bidders individually for clarification of their bids. The request for clarification and the response shall be in writing but no change in the price or substance of the bid offered shall be permitted.
12. After evaluation, the work shall be awarded normally to the Agency fulfilling all the conditions and who has quoted the lowest rate as per financial bid after complying with all the Acts / provisions stated / referred to for adherence in the tender.

13. The competent authority of AIIMS, Bhubaneswar reserved all rights to accept or reject any/ all tender(s) without assigning any reason thereto. It can also impose/relax any term and condition of the tender enquiry after due discussion in pre bid conference. This will be communicated to all tenderers' in writing. AIIMS, Bhubaneswar also reserves the right to reject any bid, which in his opinion is non-responsive, or violating any of the conditions/specifications without any liability to any loss whatsoever it may cause to the Tenderer in the process.
14. Tender must be submitted on the prescribed Tender Form otherwise tender will be cancelled straightway.
15. Canvassing in any form is strictly prohibited and the tenderer who are found canvassing are liable to have their tenders rejected out rightly. Family members of any employee of AIIMS, Bhubaneswar are not eligible to participate in the tender.

(B) OTHER TERMS & CONDITIONS OF THE TENDER

1. Rates quoted should be inclusive of all applicable taxes, packing, forwarding, postage and transportation charges at FOR AIIMS Bhubaneswar along with installation.
2. All the rates should be mention in Indian national currency (INR) only. The rates quoted in foreign currency will not be entertained in this tender enquiry & such tenders will be cancelled straightway.
3. Rates should be mentioned both in figures and in words. The offer should be typed or written in Ink Pen/ Ball Pen without any correction. Offers in pencil will be cancelled. Telegraphic/ Telex/ Fax offers will not be considered and cancelled straightway.
4. The supplier shall submit a notarised affidavit on Indian Non Judicial Stamp Paper of Rs.10/- that you have not quoted the price higher than previously supplied to any government Institute/Organisation/reputed Private Organisation or DGS&D rate in recent past. Therefore, if at any stage it has been found that the supplier has quoted lower rates than those quoted in this tender, the Institute (the purchaser) would be given the benefit of lower rates by the Supplier. If such affidavit is not submitted, tender will be out rightly rejected.
5. If the price/prices of the contracted articles is/are controlled by the Government, in no circumstances the payment will be higher than the controlled rate.
6. Tender will be regarded as constituting an offer open to acceptance in whole or in part at the discretion of the competent authority of the institute for a period of 180 days (6 months) valid from the date of opening of the tender by the committee.

7. The time for the date of delivery/ dispatch stipulated in supply order shall be deemed to be essence of the contract and if the supplier fails to deliver or dispatch any consignment within the period prescribed for such delivery or dispatch in the supply order, liquidated damages may be deducted from the bill @ 0.5% per week subject to maximum of 10% of the value of the delayed goods or services under the contract. The competent authority of the institute may also cancel the supply. In such a case, bid security of the supplier shall stand forfeited.
8. In case the quality of goods supplied are not in conformity with the standard given in tender and as per the samples supplied or the supplies are found defective at any stage these goods shall immediately will be taken back by the supplier and will be replaced with the tender quality goods, without any delay. The competent authority reserves all rights to reject the goods if the same are not found in accordance with the required description / specifications and liquidates damages shall be charged.
9. In case the tenderer on whom the supply order has been placed, fails to made supplies within the delivery schedule and the purchaser has to resort risk purchase, the purchaser (AIIMS, Bhubaneswar) may recover from the tender the difference between the cost calculated on the basis of risk purchase price and that calculated on the basis of rates quoted by tenderer. In case of repeated failure in supplying the order goods the supply order may be cancelled and bid security deposit will be forfeited.

10. Terms and Mode of Payment

10.1 Payment Terms

Payment shall be made subject to recoveries, if any, by way of liquidated damages or any other charges as per terms & conditions of contract in the following manner.

- 10.2 70 % payment of the contract price shall be paid on receipt and installation of goods in good condition at the consignee premises and balance 30% will be paid after one month on receipt of proper functioning from the concern Dept. / Division.
- 10.3 The supplier shall not claim any interest on late payments under the contract.
- 10.4 Where there is a statutory requirement for tax deduction at source, such deduction towards income tax and other tax as applicable will be made from the bills payable to the Supplier at rates as notified from time to time.
- 10.5 The supplier shall send its claim for payment in writing, when contractually due, along with relevant documents etc., duly signed with date, to the consignee.

- 10.6 While claiming payment, the supplier is also to certify in the bill that the payment being claimed is strictly in terms of the contract and all the obligations on the part of the supplier for claiming that payment has been fulfilled as required under the contract.
- 10.7 While claiming reimbursement of duties, taxes etc. (like sales tax, excise duty, custom duty) from the Purchaser/Consignee, as and if permitted under the contract, the supplier shall also certify that, in case it gets any refund out of such taxes and duties from the concerned authorities at a later date, it (the supplier) shall refund to the Purchaser/Consignee forthwith.
- 10.8 In case the supplier is not in a position to submit bill for the balance payment for want of receipted copies of Inspection Note from the consignee and the consignee has not complained about the non-receipt, shortage, or defects in the supplies made, balance amount will be paid by the paying authority without consignee's receipt certificate after three months from the date of the preceding part payment for the goods in question subject to the following conditions:
- 10.9 Warranty- The warranty on LED Signage including accessories shall be for a period of 05 (Five) years from the date of installation.
- 10.10 CMC – CMC shall be @5% of the original/ bank cost increasable @ 3% from 6th to 10th year. The CMC should be mentioned in a separate sheet, but not in the Financial Bid. Resorting to CMC is optional for the institute.
- 10.11 The up-time guarantee shall be 99% of the 365 days a year. The downtime penalty shall be twice the period beyond 1% of 365 days to be extended on warranty period or penalty of Rs. 1000/- on each night.
11. The Specification and quantity of the item needed is mentioned in Financial Bid but subject to increase/decrease at the discretion of the competent authority of AIIMS, Bhubaneswar. The payment would be made for actual supply taken/work done and no claim in this regard should be entertained.
12. Where the specifications are as per tenderer's range of product & tenderer's offer should mention that the item meets all specifications as per the tender enquiry and if there are improvements/deviations the same should be brought out on separate Letter Head of the firm. It would be discretion of the competent authority of the institute to accept or reject such deviations which are not in accordance with our required specifications as per given in Annexure - I.

The validity period of the authorization letter must be mentioned in the authority letter otherwise tender will be liable to rejection.
14. The tenderers should submit along with the tender, a photo state copy of the last 3 years Income Tax return and copy of current valid Income Tax Clearance Certificate (IT CC) otherwise tender may be ignored.
15. Full description & specifications, make/brand and name of the manufacturing firm must be clearly mentioned in the tender failing, which the tender will not be considered. Descriptive literature /catalogues must be attached with the tender in original failing which tender may be ignored.
16. Any failure or omission to carryout of the provisions of this supply by the supplier shall not give rise to any claim by supplier and purchaser one against the other, if such failure or omission arise from an act of God which shall include all acts of natural calamities from civil strikes compliance with any status and or requisitions of the Government lockout and Strikes, riots, embargoes or from any political or other reasons beyond the suppliers control including war (whether declared or not) civil war or state of incarceration provided that notice of the occurrence of any event by either party to the other shall be within two weeks from the date of occurrence of such an event which could be attributed to force majeure to be proved on record.

17. The Courts at Bhubaneswar (Odisha) alone and no other Court will have the jurisdiction to try the matter, dispute or reference between the parties arising out of this tender/supply Order/contract.
18. If at any time, any question, dispute or difference whatever shall arise between supplier and the institute (Purchaser) upon or in relation to or in connection with the agreement, either of the parties may give to the other notice in writing of the existence of such a question, dispute or difference and the same shall be referred to two arbitrators one to be nominated by the institute (Purchaser) and the other to be nominated by the supplier. Such a notice of the existence of any question dispute or difference in connection with the agreement shall be served by either party within 60 days of the beginning of such dispute failing which all Right sand claims under this Agreement shall be deemed to have been forfeited and absolutely barred.
- Before proceeding with the reference the arbitrators , if necessary , may appoint/nominate an umpire. In the event of the arbitrators not agreeing in their award the Umpire Appointed by them shall enter upon the reference and his award shall be binding on the Parties. The venue of the arbitration shall be at Bhubaneswar, (Chhattisgarh, India). The arbitrators/Umpire shall give reasoned award.
19. The supplier should mention the compliance to the specification in the technical bid of the tender document failing this, the bid document will be disqualified.
20. The bidder must have executed one similar completed work each of value not less than 80% of the estimated cost or two similar completed works each of value not less than 60% of the estimated cost of three similar completed work each of value not less than 40% of the estimated cost within last seven year Govt. sectors, PSUs, Hospitals, other big similar organisations etc., and should submit the completion certificate.
