Chapter-II- Conditions of Contract

General Terms and Conditions

Terms & Conditions:

- 1. Tender Fee:** The bidder shall be required to submit the Tender Fee (Non-Refundable) for an amount of Rs.2,000/- (Rupees Two Thousand Only) in shape of Demand Drafts only drawn in favour of “AIIMS Bhubaneswar”, Payable at Bhubaneswar. **No cost of tender document shall be charged for the tender documents if downloaded by the bidders from the website of AIIMS, Bhubaneswar.**
- 2. Earnest Money Deposit:** The bidder shall be required to submit the Earnest Money Deposit (EMD)/ Bid Security for an amount of Rs.44,000/- (Rupees Forty Four Thousand only) in the shape of DD/FDR/BG only pledged in favour of AIIMS Bhubaneswar, valid for a period 180 days (TENDERS NOT ACCOMPANIED WITH TENDER FEES (as applicable) AND EMD/BID SECURITY ALONGWITH THE BID DOCUMENT SHALL BE SUMMARILY REJECTED).
- 3. Rate:** Rates should be quoted in Indian Rupees (INR) on F.O.R destination Basis i.e.at Central Stores,AIIMS, Bhubaneswar, Odisha, Inclusive of all the Charges, with break-up as:
 - Basic Cost.
 - GST as applicable.
 - Total Cost (F.O.R at AIIMS Bhubaneswar).
 - The price per unit should be quoted as mentioned in the financial bid format. When there is a tie in the price of the lowest quoted bidders, lottery will be done in the presence of the bidders to finalize the selected bidder or it will finalised as per rules.
- 4. Validity:** The quoted rates must be valid for a period for 60 days from the date of closing of the tender. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it may be rejected.

In case the tenderer withdraws, modifies or changes his offer during the validity period, bid is liable to be rejected and the Earnest Money Deposit shall be forfeited without assigning any reason thereto. The Tenderer should also be ready to extend the validity, if required, without changing any terms, conditions etc. of their original Tender on mutual consent.
- 5. FALL CLAUSE :** If, at any time, during the said period, the supplier reduces the said prices of such Stores/Equipment/items or sales such stores/items to any other person/organization/Institution at a price lower than the price chargeable, it shall forthwith notify such reduction of price to the Director, All India Institute of Medical Sciences (AIIMS) Bhubaneswar and the price payable for the Stores supplied after the date of coming into force of such reduction or sale shall stand correspondingly reduced.
- 6. Performance Security:** (a)The successful tenderer will be required to furnish a Performance Security Deposit (PSD) value i.e. 10% (Ten Percent) of the Purchase Order Value in the shape Bank Guarantee/FDR/TDR from any Scheduled Bank duly pledged in the name of "All India Institute of Medical Sciences, Bhubaneswar". The EMD/Security money deposit can be forfeited by this Institute in the event of any breach or negligence or non-observance of any condition of contract or for unsatisfactory performance as per the Contract Agreement. Performance Security should be kept valid for Warranty period (02 year) of **Metral Bed (Rot iron) plus 60 (Sixty) days i.e. 26 Months.**
- 7. Payment Term:** 100% payment of the total order value shall be released after the successful supply of all quantity of Metal Bed (Rot Iron) at AIIMS, BBSR and acceptance receipt from the user department . The provision of Advance is not permissible but, Part payment against part supply is acceptable not exceeding 03 installments within the date of delivery as per Purchase Order. The payment shall be made within 30 days after

successful supply of Metal Bed (Rot Iron) and submission of PSD along with three copies of Invoice.

8. Delivery period: Supply should be commenced within 10-15 days from the issue of Purchase Order. Part supply is accepted i.e. phase wise the total supply to be completed within 30 days.

9. If the deliveries are not maintained and due to that account Procuring Entity is forced to buy the material from other sources, that will be at your risk and cost and the loss or damage that may be sustained there by will be recovered from the defaulting supplier.

10. Late Delivery Charges: If the supplier fails to complete the supplies within the stipulated time period then penalty@0.5% per week or part thereof exceeding three days from the date of expiry of allowable time as stipulated above (the date of issue of Purchase Order and the date of delivery excluded) of the basic cost shall be levied subject to maximum of @10% of order value.

11. Dispute clause: Any dispute relating to the enquiry shall be subject to the jurisdiction of the court at Bhubaneswar only.

12. Bidder shall submit the Tender document and additions there to, if any, with each page signed with seal to confirm the acceptance of the entire Terms & Conditions as mentioned in the tender enquiry document.

13. Compliance sheet of the Technical Specification of the goods/ Technical printed literature must be enclosed with the bid under due signature & Seal of the bidder.

14. After due evaluation of the bid(s) Institute will award the contract to the responsive tenderer who has quoted the lowest Price.

15. Conditional Bids will be treated as unresponsive and therefore may be rejected.

16. The Institute reserves the right to accept in part or in full or reject any or more Tender / offer without assigning any reasons or cancel the tendering process and reject all Tender at any time prior to award of contract, without accepting any liability, whatsoever.

17. The Director, AIIMS Bhubaneswar, India has the full and exclusive right to accept or reject, increase or decrease order quantity of any or all the tenders without assigning any reasons thereof and also to cancel the supply at any time without assigning any reason.

18. SUBMISSION OF BID:

The bidders may submit the bid as mentioned below:-

- Technical & Financial bid (Both in one sealed envelope)

- EMD in another sealed envelope.
- The above two envelopes inside the third sealed envelope marked as “**Tender for Supply of Metal Bed (Rot Iron) for the Hostel at AIIMS, Bhubaneswar**” sealed with sealing wax.

19. Debarment from bidding.

- (i) A bidder shall be debarred if he has been convicted of an offence-
- (a) under the Prevention of Corruption Act, 1988; or
 - (b) the Indian Penal Code or any other law for the time being in force, for causing any loss of life or property or causing a threat to public health as part of execution of a public procurement contract.
- (ii) A bidder debarred under sub-section (i) or any successor of the bidder shall not be eligible to participate in a procurement process of any procuring entity for a period not exceeding three years commencing from the date of debarment. Department of Commerce (DGS&D) will maintain such list which will also be displayed on the website of DGS&D as well as Central Public Procurement Portal.
- (iii) A procuring entity may debar a bidder or any of its successors, from participating in any procurement process undertaken by it, for a period not exceeding two years, if it determines that the bidder has breached the code of integrity. The Ministry/Department will maintain such list which will also be displayed on their website.
- (iv) The bidder shall not be debarred unless such bidder has been given a reasonable opportunity to represent against such debarment.

20. Applicable Law:

- i. The contract under this tender shall be governed by the laws and procedures established by Government of India, within the framework of applicable legislation and enactment made from time to time concerning such Commercial dealings / processing.
- ii. Any disputes are subject to exclusive jurisdiction of Competent Court and Forum in Bhubaneswar, Odisha, India only.
- iii. The Arbitration for any dispute or differences shall be held in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and the venue of arbitration shall be at Bhubaneswar. The decision of the Arbitrator shall be final and binding on both the parties.
- iv. Force Majeure: Any delay due to Force Majeure will be attributable to the supplier unless provided through precordial evidence.
