The College of Nursing, AIIMS Bhubaneswar, extends a warm welcome and heartfelt congratulations to all candidates who have been allotted seats in the B.Sc. (Hons) Nursing Programme (August 2026 Session).

Candidates are advised to carefully read and strictly comply with the following instructions to ensure a smooth admission process.

1. Reporting for Admission

Candidates who have been allotted AIIMS Bhubaneswar through the AIIMS Online Seat Allocation Process are required to report in person for document verification and admission formalities as per the schedule below:

First Round Reporting Date:

11 August 2026 (Tuesday) to 17 August 2026 (Monday)

Second Round Reporting Date:

24 August 2026 (Monday) to 29 August 2026 (Saturday)

Reporting Time:

- ❖ Monday to Friday: 11:00 AM to 4:00 PM
- ❖ Saturday: 11:00 AM to 12:00 Noon

Reporting Venue: Computer Laboratory, 2nd Floor, College of Nursing, AIIMS Bhubaneswar

Joining shall be subject to successful verification of original documents, eligibility criteria prescribed by AIIMS New Delhi, payment of the prescribed admission fee, and completion of all admission formalities.

2. Educational and Other Essential Documents

Candidates must produce the following original documents along with one set of self-attested photocopies:

1. AIIMS Offer Letter
2. Seat Allotment Letter
3. Final Registration Slip
4. AIIMS Admit Card
5. AIIMS Rank Card
6. Class X (Matriculation) Certificate and Mark Sheet (Proof of Date of Birth)
7. Class XII (+2) Certificate and Mark Sheet with 55% marks for Gen/OBC/EWS candidates and 50% marks for SC/ST candidates (in aggregate in the subjects of English, Physics, Chemistry and Biology)
8. Migration Certificate (where applicable)
9. The Candidate should also bring the following certificate, if applicable*:
 - a. **SC/ST/OBC/EWS Certificate*** issued by the competent authority and should be in English or Hindi language. Community and resolution number should be clearly mentioned in the certificate. OBC/EWS certificate should be same as provided to Examination Section, AIIMS, New Delhi at the time of submission of application.
 - b. The eligibility of the **OBC (NCL) /EWS certificate** shall be determined strictly in accordance with provisions of the Prospectus, including the prescribed cut-off date and validity requirements. Note: OBC Certificate* should be issued by the competent authority for central Govt. jobs/for admission in Central Govt. College/Institute. The sub-caste and resolution number should tally with the Central List Page 494 of 496 B.Sc. (Hons.) Nursing 2026 Result Notification No. 244/2026 of OBC. OBC Certificates that are applicable only for respective State Governments shall not be acceptable. OBC certificate must be in the Central Govt. Format as prescribed in the prospectus. OBC Candidates should not belong to Creamy Layer.
- * The allocated seat of candidates who fail to produce valid certificates of respective constitutional categories (OBC/SC/ST/EWS) will be forfeited and the candidates will be permitted to participate in further rounds under UR category subject to conditions applicable to UR merit list.
10. Valid Certificate of Benchmark Disability (PwBD), wherever applicable, issued by the competent Medical Board as prescribed in the AIIMS Prospectus.
11. Five recent passport-size colour photographs (front-facing).

3. Additional Forms/Documents

Candidates shall submit the following duly completed documents at the time of admission:

1. Candidate Information Sheet (Appendix-A)
2. Affidavit by Parent/Guardian on Non-Judicial Stamp Paper of ₹10/- (Appendix-B)
3. Affidavit by the Student on Non-Judicial Stamp Paper of ₹10/- (Appendix-C)

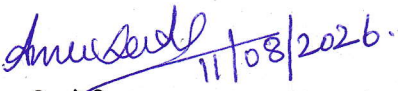
4. Admission Formalities, Hostel Allotment and Commencement of Classes

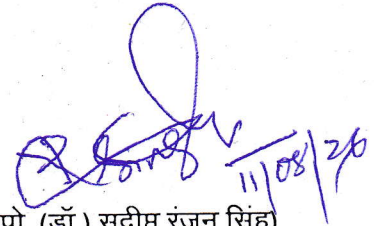
- I. Admission fee shall be paid on **31 August 2026** through Bank DD or Online Payment for **₹3,615/-** (Rupees Three Thousand Six Hundred Fifteen only) in Account No.: **557810110001482**. Demand Draft can be drawn in favour of 'AIIMS Bhubaneswar Academic Fund' (Account No.: 557810110001482). Candidates should clearly write their Name, Mobile Number, AIIMS All India Rank on the reverse side of the Bank DD.
- II. For procuring the medical fitness reports at AIIMS Bhubaneswar, the candidates shall bring the following investigations conducted in a Government Hospital or NABL-accredited Laboratory: Chest X-ray (PA View), Random Blood Sugar (RBS), Complete Urine Examination, Blood Group and Rh Factor B.
- III. Candidates who have successfully completed document verification shall be required to report along with prescribed medical fitness reports, and admission fee for joining formalities **on 31 August 2026** at the College of Nursing, AIIMS Bhubaneswar.
- IV. Hostel accommodation will be allotted only after completion of all joining formalities (31 August 2026). Candidates are therefore advised to complete the admission process within the stipulated time and carry the necessary personal belongings required for hostel stay.
- V. The B.Sc. (Hons) Nursing (August 2026 Session) classes will commence from **1st September 2026**. All admitted students are required to attend the inaugural programme/orientation session and subsequent classes as per the academic schedule. Attendance from the first day of commencement of classes is mandatory.

Candidates are advised to regularly visit the AIIMS Examination website and the AIIMS Bhubaneswar website for any further instructions, notices or updates regarding admission.
