Consequent upon the recommendations of the duly constituted Scrutiny Committee and the subsequent approval of the Competent Authority, the **Final Eligibility Status** of the applicants who have applied for engagement to the post of **Assistant Professor (Contractual)** in various Departments of AIIMS Bhubaneswar, pursuant to the advertisement referred to at **Sl. No. 1** above, has been finalized.

The final eligibility status has been determined in continuation of the Notification referred to at **Sl. No. 2** above, after due examination of the representations, clarifications, and supporting documents submitted by the candidates who were earlier declared **Provisionally Eligible** or **Not Eligible**, within the stipulated timeline, and in accordance with the terms and conditions of the advertisement, the prescribed eligibility criteria, and the recommendations of the Scrutiny Committee.

Accordingly, the candidates have been categorized as **Eligible, Provisionally Eligible, or Not Eligible**, strictly on the basis of the prescribed eligibility criteria, the terms and conditions of the advertisement, and the documentary evidence furnished by the respective candidates. The **Final Eligibility List**, indicating the eligibility status of each applicant along with the reasons thereof, is enclosed herewith as **ANNEXURE-A** for information and necessary action by the concerned candidates.

Important Notes:

1. Candidates who are presently serving under the Central Government, State Government, Autonomous Bodies, or any AIIMS (including serving employees of AIIMS Bhubaneswar) are required to produce a valid **No Objection Certificate (NOC)** issued by their present employer, in accordance with the terms and conditions of the advertisement. **No candidate shall be permitted to appear for the Personal Interview without producing the requisite NOC.**
2. Candidates applying against OBC-reserved vacancies shall produce a **valid OBC (Non-Creamy Layer) Certificate** in the prescribed format issued by the Competent Authority. The certificate must pertain to the **Financial Year 2026-27**, in accordance with the extant instructions issued by the Government of India from time to time. Candidates must also ensure that their caste/community is included in the Central List of Other Backward Classes (OBCs). **Failure to produce a valid OBC (NCL) Certificate shall render the candidate ineligible to appear for the Interview.**
3. Candidates applying against Economically Weaker Sections (EWS) reserved vacancies shall produce a **valid EWS Certificate** in the prescribed format issued by the Competent Authority. The certificate must pertain to the **Financial Year 2026-27** and shall be in conformity with the prevailing guidelines of the Government of India. **Candidates failing to produce a valid EWS Certificate shall not be permitted to appear for the Interview.**
4. All **Eligible and Provisionally Eligible** candidates who have opted to appear in the **Physical Mode** are advised to report at the notified venue at least 30 minutes prior to the scheduled reporting time for completion of pre-interview formalities.
5. Candidates who have opted for the **Online (Video Conferencing) mode** of interview shall receive the Meeting Link, Login Credentials, and detailed instructions on their registered e-mail addresses, as furnished in the online application form, sufficiently in advance of the scheduled interview.
6. The candidature of all candidates shortlisted for the Interview is purely provisional and subject to the fulfilment of the eligibility criteria with regard to Age, Educational Qualifications, Experience, Reservation Status, Medical Registration Certificate, and all other conditions prescribed in the advertisement. If, at any stage of the recruitment process or thereafter, any candidate is found to be ineligible or to have furnished false, incorrect, or incomplete information, his/her candidature shall be cancelled forthwith, without any further notice.
